1 AN ACT to amend and reenact §46A-6-107 of the Code of West Virginia, 1931, as amended,
2 relating to disclaimers and exclusions of warranties for used manufactured homes;
3 providing that a consumer may waive the warranties of merchantability and fitness for a
4 particular use; providing that a consumer may waive a particular defect or malfunction
5 which the merchant has identified and disclosed in writing to the consumer; providing for
6 the manner and content of waivers; and providing a definition.

Be it enacted by the Legislature of West Virginia:

ARTICLE 6. GENERAL CONSUMER PROTECTION.

§46A-6-107. Disclaimer of warranties and remedies prohibited.

1 (a) Except as otherwise provided in subsection (b) of this section, with respect to goods
2 which are the subject of or are intended to become the subject of a consumer transaction, no
3 merchant may:

4 (1) Exclude, modify, or otherwise attempt to limit any warranty, express, or implied,
5 including the warranties of merchantability and fitness for a particular purpose; or

6 (2) Exclude, modify or attempt to limit any remedy provided by law, including the measure
7 of damages available, for a breach of warranty, express, or implied.

8 (b) A consumer who purchases a used manufactured home may waive the warranties of
9 merchantability and fitness for a particular purpose, or waive a warranty as to a particular defect
10 or malfunction which the merchant has identified and disclosed in writing to the consumer, if the
11 used manufactured home is not being sold for human habitation: *Provided*, That notice be posted
12 on the front door of the used manufactured home that it is not being sold for human habitation:
13 *Provided, however*, That the waiver is not effective unless the waiver:

14 (1) Is in writing;

15 (2) Is conspicuous and is in plain language;

16 (3) Identifies with particularity the disclosed defect or malfunction, if any, in the used
17 manufactured home for which the warranty is to be waived;

18 (4) Describes any additional defects or malfunctions, if any, disclosed to the merchant by
19 a previous owner of the used manufactured home or discoverable by the merchant after an
20 inspection of the used manufactured home;

21 (5) States that the warranty being waived applies only to the disclosed defect or
22 malfunction, if any, to the extent the merchant intends to waive a warranty as to a specific defect;


23 (6) Acknowledges that the used manufactured home will not be used for human habitation:
24 *Provided*, That the consumer shall sign or initial such provision in order to evidence the
25 consumer's acknowledgment thereof; and

26 (7) Is signed by both the consumer and the merchant before the sales contract is executed.

27 For purposes of this subsection, "used manufactured home" means a manufactured home,
28 as defined in §21-9-2 of this code, that is more than four years old from its date of production and
29 has previously been occupied, used, or sold for purposes other than resale.


