1 AN ACT making a supplementary appropriation of federal funds out of the Treasury from the
2 balance of federal moneys remaining unappropriated for the fiscal year ending June 30,
3 2018, to the Department of Agriculture, Fund 8736, fiscal year 2018, Organization 1400,
4 and to the Department of Agriculture – State Conservation Committee, Fund 8783, fiscal
5 year 2018, Organization 1400, by supplementing and amending the appropriations for the
6 fiscal year ending June 30, 2018.

7 WHEREAS, The Governor has established the availability of federal funds for expenditure
8 in the fiscal year ending June 30, 2018 which is hereby appropriated by the terms of this
9 supplementary appropriation bill; therefore

10 *Be it enacted by the Legislature of West Virginia:*

11 That the total appropriation for the fiscal year ending June 30, 2018, to Fund 8736, fiscal
12 year 2018, Organization 1400, be supplemented and amended by increasing an existing item and
13 adding a new item of appropriation as follows:






