1 AN ACT making a supplementary appropriation of federal funds out of the Treasury from the
2 balance of federal monies remaining unappropriated for the fiscal year ending June 30,
3 2018, to the Department of Health and Human Resources, Division of Human Services,
4 fund 8722, fiscal year 2018, organization 0511, by supplementing and amending the
5 appropriations for the fiscal year ending June 30, 2018.

6 Whereas, The Governor has established the availability of federal funds for expenditure
7 in the fiscal year ending June 30, 2018 which is hereby appropriated by the terms of this
8 supplementary appropriation bill; therefore

9 *Be it enacted by the Legislature of West Virginia:*


