1 AN ACT making a supplementary appropriation of federal funds out of the Treasury from the
2 balance of federal monies remaining unappropriated for the fiscal year ending June 30,
3 2018, to the Department of Health and Human Resources, Division of Health – Community
4 Mental Health Services, fund 8794, fiscal year 2018, organization 0506, by supplementing
5 and amending the appropriations for the fiscal year ending June 30, 2018.

6 Whereas, The Governor has established the availability of federal funds for expenditure
7 in the fiscal year ending June 30, 2018 which is hereby appropriated by the terms of this
8 supplementary appropriation bill; therefore

9 *Be it enacted by the Legislature of West Virginia:*

10 That the total appropriation for the fiscal year ending June 30, 2018, to fund 8794, fiscal
11 year 2018, organization 0506, be supplemented and amended by increasing an existing item of
12 appropriation as follows:




