1 AN ACT to amend and reenact §64-2-1 of the Code of West Virginia, 1931, as amended, relating
2 to authorizing the Department of Administration to promulgate a legislative rule relating to
3 parking; and authorizing the Department of Administration to promulgate a legislative rule
4 relating to state-owned vehicles.

Be it enacted by the Legislature of West Virginia:

**ARTICLE 2. AUTHORIZATION FOR DEPARTMENT OF ADMINISTRATION TO
PROMULGATE LEGISLATIVE RULES.**

§64-2-1. Department of Administration.

1 (a) The legislative rule filed in the State Register on July 25, 2017, authorized under the
2 authority of §5A-10-3a of this code, relating to the Department of Administration (parking, 148
3 CSR 6), is authorized.

4 (b) The legislative rule filed in the State Register on July 26, 2017, authorized under the
5 authority of §5A-3-48 of this code, modified by the Department of Administration to meet the
6 objections of the Legislative Rule-Making Review Committee and refiled in the State Register on
7 December 11, 2017, relating to the Department of Administration (state-owned vehicles, 148 CSR
8 3), is authorized with the amendments set forth below:

9 On page 5, subsection 7.4, after the word “as”, by inserting the words “well as”;

10 On page 5, subdivision 7.4.b, by striking out the words “or replacement” and inserting in
11 lieu thereof the words “to or replacement of a state-owned vehicle”;

12 On page 6, subsection 8.4, after the words “otherwise exchange information. The use of”
13 by inserting the word “a”;

14 On page 6, subsection 8.5, by striking out the word “regulations” and inserting in lieu
15 thereof the word “rules”;

16 On page 7, subsection 9.2, after the words “Subsection 9.1.”, by adding the words “of this
17 section”;

18 On page 7, subdivision 9.3.c, by striking out the words “bases where the” and inserting in
19 lieu thereof the words “basis where the location requiring the”;

20 On page 7, subdivision 9.3.e, by striking out the word “lien” and inserting in lieu thereof
21 the word “liens”;

22 On page 7, subdivision 9.4, by striking out “9.3.b. or 9.3.c.” and inserting in lieu thereof
23 the words “subdivision 9.3.b or subdivision 9.3.c of this subsection”;

24 On page 9, subdivision 11.2.f, by striking out the word “state”;

25 On page 10, subdivision 11.2.j, by striking out the word “state-owned”;

26 On page 10, subdivision 11.2.k, by striking out the word “state-owned”;

27 On page 10, subdivision 11.2.l, by striking out the word “state-owned”;

28 On page 10, subsection 11.3, by striking out the words “cost and” and inserting in lieu
29 thereof the words “costs and the”;

30 And,

31 On page 10, subdivision 12.2.a, after the word “outside” by inserting the word “the”.
