1 AN ACT to amend the Code of West Virginia, 1931, as amended, by adding thereto a new section,  
2 designated §17A-2-12a, relating generally to application forms prescribed by the  
3 Commissioner of the West Virginia Division of Motor Vehicles; providing that the  
4 commissioner shall prescribe and provide suitable forms of application which provide  
5 certain applicants the ability to make a contribution to the West Virginia Department of  
6 Veterans Assistance; providing that the contributions be added, as appropriate, to the  
7 regular fee charged; providing that contributions be used exclusively for stated purposes;  
8 providing that the department shall determine the total amount collected and report the  
9 amount to the State Treasurer; providing that the State Treasurer shall transfer the amount  
10 collected to the West Virginia Department of Veterans Assistance; providing that the West  
11 Virginia Department of Veterans Assistance shall reimburse the division for the actual  
12 costs incurred by the division in administering the requirements of this section.

## **ARTICLE 2. DIVISION OF MOTOR VEHICLES.**

### **§17A-2-12a. Commissioner of Motor Vehicles — commissioner shall prescribe forms providing for veteran contributions.**

1 (a) Notwithstanding §17A-2-12 of this code, the commissioner shall prescribe and provide  
2 suitable forms of application which provide the following applicants the ability to make a  
3 contribution of \$3, \$5, or \$10 to the West Virginia Department of Veterans Assistance:

- 4 (1) Applicants for original or renewal driver's licenses or identification cards; and  
5 (2) Applicants for a renewal of a vehicle registration.

6 (b) A contribution under §17A-2-12a(a) of this code shall be added, as appropriate, to the  
7 regular fee for:

- 8 (1) An original or renewal driver's license or identification card; and  
9 (2) A renewal of a vehicle registration.


10 (c) Contributions under §17A-2-12a(a) of this code shall be used exclusively for purposes  
11 set forth in §9A-1-1 *et seq.* of this code.

12 (d) The division shall determine on a monthly basis the total amount collected under this  
13 section and report and transfer said amount to the State Treasurer. The State Treasurer shall  
14 transfer the amount collected under this section to the West Virginia Department of Veterans  
15 Assistance.

16 (e) The West Virginia Department of Veterans Assistance shall reimburse the Motor  
17 Vehicle Fees Fund for the actual costs incurred by the division in the administration of this section.




