1 AN ACT making a supplementary appropriation of Lottery Net Profits from the balance of moneys  
2 remaining as an unappropriated balance in Lottery Net Profits to the Bureau of Senior  
3 Services - Lottery Senior Citizens Fund, fund 5405, fiscal year 2018, organization 0508,  
4 by supplementing and amending the appropriations for the fiscal year ending June 30,  
5 2018.

6 Whereas, The Governor submitted the Executive Budget Document to the Legislature on  
7 January 10, 2018, which included a statement of the Lottery Fund setting forth therein the  
8 unappropriated cash balance as of July 1, 2017, and further included the estimate of revenues  
9 for the fiscal year 2018, less regular appropriations for fiscal year 2018; and

10 Whereas, It appears from the Governor's statement of the Lottery Fund, there now  
11 remains an unappropriated balance in the State Treasury which is available for appropriation  
12 during the fiscal year ending June 30, 2018; therefore

13 *Be it enacted by the Legislature of West Virginia:*

14 That the total appropriation for the fiscal year ending June 30, 2018, to fund 5405, fiscal  
15 year 2018, organization 0508, be supplemented and amended by increasing an existing item of  
16 appropriation as follows:
