1 AN ACT to amend and reenact §12-4-7 of the Code of West Virginia, 1931, as amended, relating
2 to changing the date for submission of the Auditor's annual report; adding the President
3 of the Senate and the Speaker of the House of Delegates as recipients of the annual
4 report; and adding requirement that certain salary information be included in the report for
5 the prior calendar year.


Be it enacted by the Legislature of West Virginia:


ARTICLE 4. ACCOUNTS, REPORTS, AND GENERAL PROVISIONS.

§12-4-7. Annual state dollar report of Auditor.

1 The Auditor shall furnish annually to the Governor, the President of the Senate, and the
2 Speaker of the House of Delegates on or before January 15, a report detailing financial
3 information for the prior calendar and fiscal year. It shall contain a statement of the receipts and
4 disbursements, under the proper general heads, during the preceding fiscal year, and show the
5 balance in the Treasury at the beginning and end of that year. It shall also contain an estimate of
6 the revenue and expenditures for the current year, with similar statements and estimates
7 respecting the school fund. It shall show the indebtedness of the state and the balances standing
8 at the end of the year to the credit of the several unexpired appropriations, specifying in each
9 case the date when the appropriation was made. It shall also contain information relating to the
10 salaries of state employees, including notation of salaries greater than \$80,000 paid during the
11 prior calendar year. The report shall be accompanied with an explanation of the amounts of
12 receipts and disbursements and the balances and estimates reported. In it the Auditor shall point
13 out any defects which may occur to him or her in the revenue laws. Furthermore, the Auditor shall
14 suggest the remedies for those deficits. If the Auditor is of the opinion that the future revenue is
15 likely to prove insufficient, then the Auditor shall recommend plans for increasing the revenue and
16 suggest new subjects of taxation, or additional taxes on the old, as he or she may deem proper.






