1 AN ACT expiring funds to the balance of the Auditor’s Office – Chief Inspector’s Fund, fund 1235,
2 fiscal year 2019, organization 1200, in the amount of \$1,500,000, from the Auditor’s Office
3 – Securities Regulation Fund, fund 1225, fiscal year 2019, organization 1200, by
4 supplementing and amending chapter 12, Acts of the Legislature, 2018, known as the
5 Budget Bill.

6 Whereas, The Legislature finds that the account balance in the Auditor’s Office –
7 Securities Regulation Fund, fund 1225, fiscal year 2019, organization 1200 exceeds that which is
8 necessary for the purpose for which the account was established; therefore

Be it enacted by the Legislature of West Virginia:

1 That the balance of funds available for expenditure in the fiscal year ending June 30, 2019,
2 to the Auditor’s Office – Securities Regulation Fund, fund 1225, fiscal year 2019, organization
3 1200, be decreased by expiring the amount of \$1,500,000 to the Auditor’s Office – Chief
4 Inspector’s Fund, fund 1235, fiscal year 2019, organization 1200.

5 And, that the total appropriation for the fiscal year ending June 30, 2019, to fund 1235,
6 fiscal year 2019, organization 1200, be supplemented and amended by increasing an existing
7 item of appropriation as follows:
