

1	AN ACT to amend the Code of West Virginia, 1931, as amended, by adding thereto a new section,
2	designated §5B-2-17, relating to creating the West Virginia Motorsport Committee; setting
3	forth who serves on the committee; setting forth its duties; requiring meetings and
4	hearings; and requiring reports.

Be it enacted by the Legislature of West Virginia:

ARTICLE 2. WEST VIRGINIA DEVELOPMENT OFFICE.

§5B-2-17. West Virginia Motorsport Committee.

- 1 (a) The West Virginia Motorsport Committee is hereby created.
- (b) The committee consists of five members, including its chairperson, appointed by the
 Governor to serve at his or her will and pleasure.
 - (c) The Commissioner of Tourism and the Director of the West Virginia Development

 Office shall also serve on the committee, ex officio.

- (1) Work with the existing facilities within the state to enhance existing racing;
- 8 (2) Develop a strategy that creates further opportunities, such as encouraging racing 9 training schools, conducting special events, and encouraging special events and the construction 10 of larger in-state racing facilities; and
 - (3) Seek opportunities to promote economic growth and manufacturing jobs related to motorsports.
 - (e) The committee shall hold regular meetings, at least quarterly, and conduct public hearings as it deems necessary.
 - (f) Members of the committee will receive no compensation but are entitled to reimbursement for mileage expenses while attending meetings of the committee to the extent that funds are available through the Development Office.
 - (g) The committee shall report on the status of its duties, goals, accomplishments and recommendations to the Legislature on at least an annual basis.
