1 AN ACT making a supplementary appropriation by adding new items of appropriation from the
2 balance of moneys remaining as an unappropriated balance in the State Fund, State
3 Excess Lottery Revenue Fund, to the Department of Administration, Office of Technology,
4 fund 2532, fiscal year 2019, organization 0231, by supplementing and amending the
5 appropriations for the fiscal year ending June 30, 2019.

6 Whereas, The Governor submitted the Executive Budget Document to the Legislature on
7 January 9, 2019, which included a statement of the State Excess Lottery Revenue Fund setting
8 forth therein the unappropriated cash balance as of July 1, 2018, and further included the estimate
9 of revenues for the fiscal year 2019, less regular appropriations for fiscal year 2019; and

10 Whereas, It appears from the Governor’s statement of the State Excess Lottery Revenue
11 Fund, there now remains an unappropriated balance in the State Treasury which is available for
12 appropriation during the fiscal year ending June 30, 2019; therefore

Be it enacted by the Legislature of West Virginia:

1 That the total appropriation for the fiscal year ending June 30, 2019, be supplemented and
2 amended by adding new items of appropriation as follows:
