1 AN ACT supplementing and amending by adding a new appropriation of federal funds out of the
2 State Treasury to the Department of Transportation, fund 8831, fiscal year 2020,
3 organization 0807, by supplementing, amending, and adding a new appropriation for the
4 fiscal year ending June 30, 2020.

5 Whereas, The Governor has established the availability of federal funds for expenditure
6 in the fiscal year ending June 30, 2020, which are hereby appropriated by the terms of this
7 supplementary appropriation bill; therefore

Be it enacted by the Legislature of West Virginia:

1 That chapter 31, Acts of the Legislature, regular session, 2019, known as the Budget Bill,
2 be supplemented and amended by adding a new item appropriation to Title II, Section 6 thereof,
