1 AN ACT making a supplementary appropriation of federal funds out of the State Treasury from  
2 the balance of federal moneys remaining unappropriated for the fiscal year ending June  
3 30, 2020, to the Department of Health and Human Resources, Division of Human  
4 Services, fund 8722, fiscal year 2020, organization 0511, by supplementing and amending
