1 AN ACT supplementing and amending Chapter 11, Acts of the Legislature, Regular Session,
2 2021, known as the Budget Bill, supplementing and amending appropriations in Title II,
3 Section 9 for the fiscal year ending June 30, 2022.

Be it enacted by the Legislature of West Virginia:

1 That Chapter 11, Acts of the Legislature, Regular Session, 2021, known as the Budget
2 Bill, in Title II, Section 9, for the fiscal year ending June 30, 2022, be supplemented and amended
3 to read as follows:

4 **Sec. 9. Appropriations from general revenue fund surplus accrued.** — The following
5 items are hereby appropriated from the state fund, general revenue, and are to be available for
6 expenditure during the fiscal year 2022 out of surplus funds only, accrued from the fiscal year
7 ending June 30, 2021, subject to the terms and conditions set forth in this section.

8 It is the intent and mandate of the Legislature that the following appropriations be payable
9 only from surplus as of July 31, 2021, from the fiscal year ending June 30, 2021, only after first
10 meeting requirements of W.Va. Code §11B-2-20(b).

11 In the event that surplus revenues available on July 31, 2021, are not sufficient to meet
12 the appropriations made pursuant to this section, then the appropriations shall be made to the
13 extent that surplus funds are available as of the date mandated to meet the appropriations in this
14 section and shall be allocated first to provide the necessary funds to meet the first appropriation
15 of this section and each subsequent appropriation in the order listed in this section.
