1 AN ACT supplementing and amending by increasing an existing item of appropriation of federal
2 funds out of the Treasury to the Miscellaneous Boards and Commissions, National Coal
3 Heritage Authority, fund 8869, fiscal year 2022, organization 0941, by supplementing and

1 Whereas, The Governor has established the availability of federal funds for expenditure
