1 AN ACT making a supplementary appropriation of federal funds out of the Treasury from the  
2 balance of federal moneys remaining unappropriated for the fiscal year ending June 30,  
3 2022, to the Department of Health and Human Resources, Consolidated Medical Service  
4 Fund, fund 8723, fiscal year 2022, organization 0506, by supplementing and amending  
5 the appropriations for the fiscal year ending June 30, 2022.






