1 AN ACT making a supplementary appropriation of public moneys out of the Treasury from the
2 balance of moneys remaining as an unappropriated balance in the State Fund, General
3 Revenue, by adding a new item of appropriation and increasing the expenditure, to the
4 Department of Education, State Board of Education, State Department of Education, fund
5 0313, fiscal year 2022, organization 0402, by supplementing and amending Chapter 11,
6 Acts of the Legislature, Regular Session, 2021, known as the Budget Bill, for the fiscal
7 year ending June 30, 2022.

8 Whereas, The Governor submitted to the Legislature the Executive Budget Document,
9 dated February 10, 2021, which included a Statement of the State Fund, General Revenue,
10 setting forth therein the cash balance as of July 1, 2020, and further included an estimate of
11 revenues for the fiscal year 2022 less net appropriation balances forwarded and regular
12 appropriations for the fiscal year 2022; and

13 Whereas, The Governor submitted to the Legislature an Executive Message dated June
14 24, 2021, which included a revised estimate of revenues for the State Fund, General Revenue,
15 and a Statement of the State Fund, General Revenue, for the fiscal year 2021, and further
16 included an estimate of revenues for the fiscal year 2022 less net appropriation balances
17 forwarded and regular appropriations for the fiscal year 2022; and

18 Whereas, It appears from the Executive Message dated June 24, 2021, Statement of the
19 State Fund, General Revenue, there remains an unappropriated balance in the State Treasury
20 which is available for appropriation during the fiscal year ending June 30, 2022; therefore

Be it enacted by the Legislature of West Virginia:

1 That Chapter 11, Acts of the Legislature, Regular Session, 2021, known as the Budget
2 Bill, be supplemented and amended by adding a new item of appropriation to Title II, Section 1
3 thereof, the following:

4 TITLE II – APPROPRIATIONS.

Section 1. Appropriations from general revenue.


