1 AN ACT supplementing and amending the appropriations of public moneys out of the Treasury
2 from the balance of moneys remaining as an unappropriated surplus balance in the State
3 Fund, General Revenue, to the Executive, Governor's Office – Civil Contingent Fund, fund
4 0105, fiscal year 2022, organization 0100, by supplementing and amending the
5 appropriations for the fiscal year ending June 30, 2022.

1 Whereas, The Governor submitted to the Legislature the Executive Budget Document,
2 dated February 10, 2021, which included a Statement of the State Fund, General Revenue, dated
3 February 10, 2021, setting forth therein the cash balance as of July 1, 2020, and further included
4 an estimate of revenues for the fiscal year 2022 less net appropriation balances forwarded and
5 regular appropriations for the fiscal year 2022; and

6 Whereas, The Governor submitted to the Legislature an Executive Message dated June
7 24, 2021, which included a revised estimate of revenues for the State Fund, General Revenue,
8 and a statement of the State Fund, General Revenue, for the fiscal year 2021, and further included
9 an estimate of revenues for the fiscal year 2022 less net appropriation balances forwarded and
10 regular appropriations for the fiscal year 2022; and

11 Whereas, It appears from the Executive Message dated June 24, 2021, Statement of the
12 State Fund, General Revenue, there now remains an unappropriated surplus balance in the State
13 Treasury which is available for appropriation during the fiscal year ending June 30, 2022;
14 therefore

Be it enacted by the Legislature of West Virginia:

1 That the total appropriation for the fiscal year ending June 30, 2022, to fund 0105, fiscal
2 year 2022, organization 0100, be supplemented and amended by adding a new item of
3 appropriation as follows:




