1 AN ACT making a supplementary appropriation by adding a new item of appropriation and
2 increasing the expenditure of public moneys out of the Treasury from the balance of
3 moneys remaining as an unappropriated balance in the State Fund, General Revenue, to
4 the Department of Administration, Division of Personnel, fund 0206, fiscal year 2022,
5 organization 0222, by supplementing and amending Chapter 11, Acts of the Legislature,
6 Regular Session, 2021, known as the Budget Bill, for the fiscal year ending June 30, 2022.

1 Whereas, The Governor submitted to the Legislature the Executive Budget Document,
2 dated February 10, 2021, which included a Statement of the State Fund, General Revenue,
3 setting forth therein the cash balance as of July 1, 2020, and further included an estimate of
4 revenues for the fiscal year 2022 less net appropriation balances forwarded and regular
5 appropriations for the fiscal year 2022; and

1 Whereas, The Governor submitted to the Legislature an Executive Message dated June
2 24, 2021, which included a revised estimate of revenues for the State Fund, General Revenue,
3 and a statement of the State Fund, General Revenue, for the fiscal year 2021, and further included
4 an estimate of revenues for the fiscal year 2022 less net appropriation balances forwarded and
5 regular appropriations for the fiscal year 2022; and

6 Whereas, It appears from the Executive Message dated June 24, 2021, Statement of the
7 State Fund, General Revenue, there remains an unappropriated balance in the State Treasury
8 which is available for appropriation during the fiscal year ending June 30, 2022; therefore

Be it enacted by the Legislature of West Virginia:

1 That Chapter 11, Acts of the Legislature, Regular Session, 2021, known as the Budget
2 Bill, be supplemented and amended by adding a new item of appropriation to Title II, Section 1
3 thereof, the following:

4 TITLE II – APPROPRIATIONS.

5 Section 1. Appropriations from general revenue.






