1 AN ACT making a supplementary appropriation of public moneys out of the Treasury from the
 2 balance of moneys remaining unappropriated for the fiscal year ending June 30, 2022, to
 3 the Department of Transportation, Public Port Authority, Special Railroad and Intermodal
 4 Enhancement Fund, fund 8254, fiscal year 2022, organization 0806, by supplementing
 5 and amending Chapter 11, Acts of the Legislature, Regular Session, 2021, known as the
 6 Budget Bill, for the fiscal year ending June 30, 2022.

1 Whereas, The Governor has established that there now remains an unappropriated
 2 balance in the Department of Transportation, Public Port Authority, Special Railroad and
 3 Intermodal Enhancement Fund, fund 8254, fiscal year 2022, organization 0806, that is available
 4 for expenditure during the fiscal year ending June 30, 2022, which is hereby appropriated by the
 5 terms of this supplementary appropriation bill; therefore

Be it enacted by the Legislature of West Virginia:

1 That Chapter 11, Acts of the Legislature, Regular Session, 2021, known as the Budget
 2 Bill, be supplemented and amended by adding a new item of appropriation to Title II, Section 3
 3 thereof, the following:
