1 AN ACT making a supplementary appropriation of federal funds out of the Treasury from the
2 balance of federal moneys remaining unappropriated for the fiscal year ending June 30,
3 2022, to the Governor's Office, Coronavirus State Fiscal Recovery Fund, fund 8823, fiscal
4 year 2022, organization 0100, by supplementing and amending Chapter 11, Acts of the
5 Legislature, Regular Session, 2021, known as the Budget Bill, for the fiscal year ending
6 June 30, 2022.

1 Whereas, The Governor has established the availability of federal funds for expenditure
2 in the fiscal year ending June 30, 2022, which are hereby appropriated by the terms of this
3 supplementary appropriation bill; therefore

Be it enacted by the Legislature of West Virginia:

1 That Chapter 11, Acts of the Legislature, Regular Session, 2021, known as the Budget
2 Bill, be supplemented and amended by adding a new item of appropriation to Title II, Section 6
3 thereof, the following:






