1 AN ACT supplementing and amending the appropriations of public moneys out of the Treasury
2 from the balance of moneys remaining as an unappropriated surplus balance in the State
3 Fund, General Revenue, to the Department of Administration, Public Defender Services,
4 fund 0226, fiscal year 2021, organization 0221, by supplementing and amending the
5 appropriations for the fiscal year ending June 30, 2021.

6 WHEREAS, The Governor submitted to the Legislature a Statement of the State Fund,
7 General Revenue, dated February 10, 2021, setting forth therein the cash balance as of July 1,
8 2020, and further included the estimate of revenues for the fiscal year 2021, less net appropriation
9 balances forwarded and regular appropriations for the fiscal year 2021; and

10 WHEREAS, It appears from the Statement of the State Fund, General Revenue, there
11 now remains an unappropriated surplus balance in the State Treasury which is available for
12 appropriation during the fiscal year ending June 30, 2021; therefore

13 *Be it enacted by the Legislature of West Virginia:*

14 That the total appropriation for the fiscal year ending June 30, 2021, to fund 0226, fiscal
15 year 2021, organization 0221, be supplemented and amended by increasing existing items of
16 appropriation as follows:
