1 AN ACT supplementing and amending the appropriations of public moneys out of the Treasury
2 from the balance of moneys remaining as an unappropriated surplus balance in the State
3 Fund, General Revenue, to the Department of Commerce, Division of Forestry, fund 0250,
4 fiscal year 2021, organization 0305, by supplementing and amending the appropriations
5 for the fiscal year ending June 30, 2021.

6 WHEREAS, The Governor submitted to the Legislature the Executive Budget document,
7 dated February 10, 2021, which included a Statement of the State Fund, General Revenue,
8 setting forth therein the cash balance as of July 1, 2020, and further included the estimate of
9 revenues for the fiscal year 2021, less net appropriation balances forwarded and regular
10 appropriations for the fiscal year 2021; and

11 WHEREAS, It appears from the Executive Budget Document, Statement of the State
12 Fund, General Revenue, and this legislation, there now remains an unappropriated surplus
13 balance in the State Treasury which is available for appropriation during the fiscal year ending
14 June 30, 2021; therefore

15 *Be it enacted by the Legislature of West Virginia:*

16 That the total appropriation for the fiscal year ending June 30, 2021, to fund 0250, fiscal
17 year 2021, organization 0305, be supplemented and amended by increasing existing items of
18 appropriation as follows:
