1 AN ACT making a supplementary appropriation of federal funds out of the Treasury from the
2 balance of federal moneys remaining unappropriated for the fiscal year ending June 30,
3 2021, to WorkForce West Virginia – Workforce Investment Act, fund 8749, fiscal year
4 2021, organization 0323, by supplementing and amending the appropriations for the
5 fiscal year ending June 30, 2021.

6 WHEREAS, The Governor has established the availability of federal funds for
7 expenditure in the fiscal year ending June 30, 2021 which is hereby appropriated by the terms
8 of this supplementary appropriation bill; therefore

9 *Be it enacted by the Legislature of West Virginia:*


