1 AN ACT expiring funds to the balance of the Department of Education – State Board of Education  
2 – School Building Authority – School Construction Fund, fund 3952, fiscal year 2021,  
3 organization 0404, in the amount of \$2,766,137, from the State Department of Education  
4 – School Building Authority – Debt Service Fund, fund 3963, organization 0404, by  
5 supplementing and amending the appropriations for the fiscal year ending June 30, 2021.

1 Whereas, The Governor finds that the account balance in the State Department of  
2 Education – School Building Authority – Debt Service Fund, fund 3963, fiscal year 2021,  
3 organization 0404, exceeds that which is necessary for the purposes for which the account was  
4 established; therefore

*Be it enacted by the Legislature of West Virginia:*

1 That the balance of funds available for expenditure in the fiscal year ending June 30, 2021  
2 to the State Department of Education – School Building Authority – Debt Service Fund, fund 3963,  
3 fiscal year 2021, organization 0404, be decreased by expiring the amount of \$2,766,137 to the  
4 Department of Education – State Board of Education - School Building Authority – School  
5 Construction Fund, fund 3952, organization 0404.
