1 AN ACT making a supplementary appropriation of federal funds out of the Treasury from the  
2 balance of federal monies remaining unappropriated for the fiscal year ending June 30,  
3 2021, to the Department of Commerce, Geological and Economic Survey, fund 8704,  
4 fiscal year 2021, organization 0306, by supplementing and amending the appropriations  
5 for the fiscal year ending June 30, 2021.

6 WHEREAS, The Governor has established the availability of federal funds for expenditure  
7 in the fiscal year ending June 30, 2021 which are hereby appropriated by the terms of this  
8 supplementary appropriation bill; therefore

9 *Be it enacted by the Legislature of West Virginia:*


