1 AN ACT to amend the Code of West Virginia, 1931, as amended, by adding thereto a new article,  
2 designated §17-30-1, relating to the Electric Vehicle Infrastructure Development Plan for  
3 National Electric Vehicle Infrastructure Formula Program funds.

*Be it enacted by the Legislature of West Virginia:*

**ARTICLE 30. ELECTRIC VEHICLE ECONOMIC DEVELOPMENT PLAN.**

**§17-30-1. Department of Transportation to develop electric vehicle plan.**

1 The Department of Transportation shall create an Electric Vehicle Infrastructure  
2 Development Plan for West Virginia that describes how our state intends to use its share of NEVI  
3 Formula Program funds. The plan shall take a wholistic approach, considering the future charging  
4 infrastructure needs of school systems, public transportation, counties and municipalities, and  
5 other public and private users. The Department shall share this plan and report with the interim  
6 Joint Committee of Government and Finance by July 1, 2022.
