1 AN ACT supplementing and amending the appropriations of public moneys out of the State  
2 Treasury from the balance of moneys remaining as an unappropriated surplus balance in  
3 the State Fund, General Revenue, to the Department of Administration, Public Defender  
4 Services, fund 0226, fiscal year 2022, organization 0221, by supplementing and amending  
5 the appropriations for the fiscal year ending June 30, 2022.

1 Whereas, The Governor submitted the Executive Budget Document to the Legislature on  
2 January 12, 2022, containing a statement of the State Fund, General Revenue, setting forth  
3 therein the cash balance as of July 1, 2021, and further included the estimate of revenue for the  
4 fiscal year 2022, less net appropriation balances forwarded and regular and surplus  
5 appropriations for the fiscal year 2022, and further included recommended expirations to the  
6 unappropriated surplus balance of the State Fund General Revenue; and

7 Whereas, It appears from the Governor’s Statement of the State Fund, General Revenue,  
8 there now remains an unappropriated surplus balance in the State Treasury which is available for  
9 appropriation during the fiscal year ending June 30, 2022; therefore

*Be it enacted by the Legislature of West Virginia:*

1 That the total appropriation for the fiscal year ending June 30, 2022, to fund 0226, fiscal  
2 year 2022, organization 0221, be supplemented and amended by adding new items of  
3 appropriation as follows:




