1 AN ACT supplementing, amending, and increasing an existing item of appropriation from the
2 State Road Fund to the Department of Transportation, Division of Highways, fund 9017,
3 fiscal year 2022, organization 0803, for the fiscal year ending June 30, 2022.

1 Whereas, The Governor submitted to the Legislature the Executive Budget Document,
2 dated January 12, 2022, which included a Statement of the State Road Fund setting forth therein
3 the cash balances and investments as of July 1, 2021, and further included the revised estimate
4 of revenues for the fiscal year 2022, less regular appropriations for the fiscal year 2022; and

5 Whereas, It appears from the Statement of the State Road Fund there now remains an
6 unappropriated balance in the State Treasury which is available for appropriation during the fiscal
7 year ending June 30, 2022; therefore

Be it enacted by the Legislature of West Virginia:

1 That the total appropriation for the fiscal year ending June 30, 2022, to fund 9017, fiscal
2 year 2022, organization 0803, be supplemented and amended by increasing an existing item of
3 appropriation as follows:
