

1	AN ACT supplementing and amending the appropriations of public moneys out of the State			
2	Treasury from the balance of moneys remaining as an unappropriated balance in the State			
3	Fund, General Revenue, to the Department of Education, State Board of Education –			
4	Vocational Division, fund 0390, fiscal year 2022, organization 0402, by supplementing and			
5	amending the appropriations for the fiscal year ending June 30, 2022.			
1	Whereas, The Governor submitted the Executive Budget Document to the Legislature on			
2	January 12, 2022, containing a statement of the State Fund, General Revenue, setting forth			
3	therein the cash balance as of July 1, 2021, and further included the revised estimate of revenue			
4	for the fiscal year 2022, less net appropriation balances forwarded and regular and surplus			
5	appropriations for the fiscal year 2022; and			
6	Whereas, It appears from the Governor's Statement of the State Fund, General Revenue,			
7	there now remains an unappropriated balance in the State Treasury which is available for			
8	appropriation during the fiscal year ending June 30, 2022; therefore			
	Be it enacted by the Legislature of West Virginia:			
1	That the total appropriation for the fiscal year ending June 30, 2022, to fund 0390, fiscal			
2	year 2022, organization 0402, be supplemented and amended by increasing an existing item of			
3	appropriation as follows:
