1 AN ACT making a supplementary appropriation of public moneys out of the State Treasury from  
 2 the balance of moneys remaining unappropriated for the fiscal year ending June 30, 2022,  
 3 to the Department of Homeland Security, Fire Commission - Fire Marshal Fees, fund 6152,  
 4 fiscal year 2022, organization 0619, by supplementing and amending the appropriations  
 5 for the fiscal year ending June 30, 2022.

1 Whereas, The Governor has established that there now remains an unappropriated  
 2 balance in the Department of Homeland Security, Fire Commission - Fire Marshal Fees, fund  
 3 6152, fiscal year 2022, organization 0619, that is available for expenditure during the fiscal year  
 4 ending June 30, 2022, which is hereby appropriated by the terms of this supplementary  
 5 appropriation bill; therefore

*Be it enacted by the Legislature of West Virginia:*

1 That the total appropriation for the fiscal year ending June 30, 2022, to fund 6152, fiscal  
 2 year 2022, organization 0619, be supplemented and amended by increasing an existing item of  
 3 appropriation as follows:
