1 AN ACT to amend the Code of West Virginia, 1931, as amended, by adding thereto a new section,
2 designated §30-3-20; and to amend said code by adding thereto a new section,
3 designated §30-14-17, all relating to prohibiting certain medical practices; defining terms;
4 prohibiting irreversible gender reassignment surgery to a minor; prohibiting the providing
5 of gender altering medication to a minor; providing exceptions; establishing an internal
6 effective date.

Be it enacted by the Legislature of West Virginia:

ARTICLE 3. WEST VIRGINIA MEDICAL PRACTICE ACT.

§30-3-20. Prohibited practice.

1 (a) For the purposes of this section:

2 "Biological sex" means the biological indication of male and female in the context of
3 reproductive potential or capacity, such as sex chromosomes, naturally occurring sex hormones,
4 gonads, and nonambiguous internal and external genitalia present at birth, without regard to an
5 individual's psychological, chosen, or subjective experience or gender.

6 "Gender" means the psychological, behavioral, social and cultural aspects of being male
7 or female.

8 "Gender altering medication" means the prescribing or administering of the following for
9 the purpose of assisting an individual with a gender transition:

10 (1) Puberty blocking medication to stop or delay normal puberty;

11 (2) Supraphysiologic doses of testosterone or other androgens to females; and

12 (3) Supraphysiologic doses of estrogen to males.

13 "Gender transition" means the process in which a person goes from identifying with and
14 living as a gender that corresponds to the person's biological sex to identifying with and living as
15 a gender different from the person biological sex and may involve social, legal, or physical
16 changes.

17 "Irreversible gender reassignment surgery" means a medical procedure performed for the
18 purpose of assisting an individual with a gender transition, including any of the following:

19 (1) Penectomy, orchiectomy, vaginoplasty, clitoroplasty, or vulvoplasty for biologically
20 male patients or hysterectomy or ovariectomy for biologically female patients;

21 (2) Metoidioplasty, phalloplasty, vaginectomy, scrotoplasty, or implantation of erection or
22 testicular prostheses for biologically female patients; and

23 (3) Augmentation mammoplasty for biological male patient and subcutaneous
24 mastectomy for female patients.

25 (b) Except as otherwise provided in §30-3-20(c), a physician may not provide irreversible
26 gender reassignment surgery or gender altering medication to a person who is under eighteen
27 years of age.

28 (c) A physician may provide any of the following to a person who is under 18 years of age:

29 (1) Services provided to an individual born with a medically verifiable disorder of sex
30 development, including, but not limited to, a person with external biological sex characteristics
31 that are irresolvably ambiguous, such as an individual born with forty-six xx chromosomes with
32 virilization, forty-six xy chromosomes with undervirilization, or having both ovarian and testicular
33 tissue;

34 (2) Services provided to an individual when a physician has otherwise diagnosed a
35 disorder of sexual development and in which the physician has determined through genetic or
36 biochemical testing that the individual does not have normal sex chromosome structure, sex
37 steroid hormone production, or sex steroid hormone action;

38 (3) The treatment of any infection, injury, disease, or disorder that has been caused by or
39 exacerbated by the performance of gender transition procedures, whether or not these
40 procedures were performed in accordance with state and federal law; and

41 (4) Any procedure undertaken because the individual suffers from a physical disorder,
42 physical injury, or physical illness that would, as certified by a physician, place the person in
43 imminent danger of death, or impairment of a major bodily function unless surgery is performed.

44 (5) Pubertal modulating and hormonal therapy for severe gender dysphoria if:

45 (A) The minor has been diagnosed as suffering from severe gender dysphoria by no fewer
46 than two medical or mental health providers with at least one being a mental health provider or
47 adolescent medicine specialist, and both having relevant training in the diagnosis and treatment
48 of severe gender dysphoria in adolescents;

49 (B) The diagnosing medical professionals express in written opinions that treatment with
50 pubertal modulating and hormonal therapy is medically necessary to treat the minor's psychiatric
51 symptoms and limit self-harm, or the possibility of self-harm, by the minor;

52 (C) The minor, the minor's parents, legal guardians, or person or other persons charged
53 with medical decision-making for the minor, and the minor's primary physician agree in writing
54 with the treatment with pubertal modulating and hormonal therapy for the minor;

55 (D) Any use of gender altering medication is for purposes of pubertal modulating and
56 hormonal therapy limited to the lowest titratable dosage necessary to treat the psychiatric
57 condition and not for purposes of gender transition; and

58 (E) Notwithstanding the provisions of paragraphs (A) through (D) of this subdivision where
59 the minor is prepubescent, hormonal treatment may not be provided;

60 (d) The provisions of this section are effective on January 1, 2024.

ARTICLE 14. OSTEOPATHIC PHYSICIANS AND SURGEONS.

§30-14-17. Prohibited practice.

1 (a) For the purposes of this section:

2 "Biological sex" means the biological indication of male and female in the context of
3 reproductive potential or capacity, such as sex chromosomes, naturally occurring sex hormones,

4 gonads, and nonambiguous internal and external genitalia present at birth, without regard to an
5 individual's psychological, chosen, or subjective experience or gender.

6 "Gender" means the psychological, behavioral, social and cultural aspects of being male
7 or female.

8 "Gender altering medication" means the prescribing or administering of the following for
9 the purpose of assisting an individual with a gender transition:

- 10 (1) Puberty blocking medication to stop or delay normal puberty;

- 12 (3) Supraphysiologic doses of estrogen to males.

54 treatment with gender altering medication for the minor;

55 (D) Any use of gender altering medication is for purposes of pubertal modulating and
56 hormonal therapy and is limited to the lowest titratable dosage necessary to treat the psychiatric
57 condition and not for purposes of gender transition; and

58 (E) Notwithstanding the provisions of paragraphs (A) through (D) of this subdivision where
59 the minor is prepubescent, hormonal treatment may not be provided.

60 (d) The provisions of this section are effective on January 1, 2024.
