1 AN ACT expiring funds to the unappropriated surplus balance in the State Fund, General
2 Revenue, for the fiscal year ending June 30, 2023, in the amount of \$30,500,000 from the
3 balance of moneys remaining as an unappropriated balance in the State Excess Lottery
4 Revenue Fund.

5 Whereas, The Governor submitted the Executive Budget Document to the Legislature on
6 January 11, 2023, containing a statement of the State Fund, General Revenue, setting forth
7 therein the cash balance as of July 1, 2022, and further included the estimate of revenues for the
8 fiscal year 2023, less net appropriation balances forwarded and regular and surplus
9 appropriations for the fiscal year 2023, and further included recommended expirations to the
10 unappropriated surplus balance of the State Fund, General Revenue; and

11 Whereas, It appears from the Governor's Statement of the State Excess Lottery Revenue
12 Fund, there now remains an unappropriated balance in the State Treasury which is available for
13 expiration during the fiscal year ending June 30, 2023; therefore

Be it enacted by the Legislature of West Virginia:

1 That the balance of the funds remaining as an unappropriated balance for the fiscal year
2 ending June 30, 2023 in the State Excess Lottery Revenue Fund be decreased by expiring the
3 amount of \$30,500,000 to the unappropriated surplus balance of the State Fund, General
4 Revenue to be available for appropriation during the fiscal year ending June 30, 2023.
