2	increasing the expenditure of public moneys out of the Treasury from the balance of			
3	moneys remaining as an unappropriated surplus balance in the State Fund, General			
4	Revenue, to Miscellaneous Boards and Commissions, Adjutant General – State Militia,			
5	fund 0433, fiscal year 2023, organization 0603, by supplementing and amending the			
6	appropriations for the fiscal year ending June 30, 2023.			
7	Whereas, The Governor submitted the Executive Budget Document to the Legislature o			
8	January 11, 2023, containing a statement of the State Fund, General Revenue, setting forth			
9	therein the cash balance as of July 1, 2022, and further included the estimate of revenue for the			
10	fiscal year 2023, less net appropriation balances forwarded and regular and surplus			
11	appropriations for the fiscal year 2023, and further included recommended expirations to the			
12	2 unappropriated surplus balance of the State Fund, General Revenue; and			
13	Whereas, It appears from the Governor's Statement of the State Fund, General Revenue,			
14	there now remains an unappropriated surplus balance in the Treasury which is available for			
15	appropriation during the fiscal year ending June 30, 2023; therefore			
	Be it enacted by the Legislature of West Virginia:			
1	That the total appropriation for the fiscal year ending June 30, 2023, to fund 0433, fiscal			
2	year 2023, organization 0603, be supplemented and amended by adding a new item of			
3	appropriation as follows:
