6	Whereas, The Governor submitted the Executive Budget Document to the Legislature o			
7	January 11, 2023, containing a statement of the State Fund, General Revenue, setting forth			
8	therein the cash balance as of July 1, 2022, and further included the estimate of revenue for the			
9	fiscal year 2023, less net appropriation balances forwarded and regular and surplus			
10	appropriations for the fiscal year 2023, and further included recommended supplemental			
11	appropriations from the balance of the State Fund, General Revenue; and			
12	Whereas, It appears from the Governor's Statement of the State Fund, General Revenue			
13	there now remains an unappropriated balance in the Treasury which is available for appropriation			
14	during the fiscal year ending June 30, 2023; therefore
