1 AN ACT supplementing and amending the appropriations of public moneys out of the Treasury
2 from the balance of moneys remaining as an unappropriated balance in the State Fund,
3 General Revenue, to Miscellaneous Boards and Commissions, Adjutant General – State
4 Militia, fund 0433, fiscal year 2023, organization 0603, by supplementing and amending
5 the appropriations for the fiscal year ending June 30, 2023.

6 Whereas, The Governor submitted the Executive Budget Document to the Legislature on
7 January 11, 2023, containing a statement of the State Fund, General Revenue, setting forth
8 therein the cash balance as of July 1, 2022, and further included the estimate of revenue for the
9 fiscal year 2023, less net appropriation balances forwarded and regular and surplus
10 appropriations for the fiscal year 2023, and further included recommended supplemental
11 appropriations from the balance of the State Fund, General Revenue; and

12 Whereas, It appears from the Governor’s Statement of the State Fund, General Revenue,
13 there now remains an unappropriated balance in the Treasury which is available for appropriation
14 during the fiscal year ending June 30, 2023; therefore

Be it enacted by the Legislature of West Virginia:

1 That the total appropriation for the fiscal year ending June 30, 2023, to fund 0433, fiscal
2 year 2023, organization 0603, be supplemented and amended by increasing an existing item of
3 appropriation as follows:
