1 AN ACT to amend and reenact §18-2-7c of the Code of West Virginia, 1931, as amended, relating
2 to requiring each high school student to complete a one-half credit course of study in
3 personal finance as a requirement for high school graduation; providing beginning class
4 of students and grade level requirement; requiring implementation guidance by State
5 Board and specifying guidance content.

Be it enacted by the Legislature of West Virginia:

ARTICLE 2. STATE BOARD OF EDUCATION.

§18-2-7c. Program in personal finance.

1 (a) The Legislature finds and declares that persons with an understanding of personal
2 finance are better prepared to manage their money and that providing a personal finance program
3 in secondary schools in West Virginia will prepare students to handle their finances.

4 (b) To provide students a basic understanding of personal finance, the state board shall
5 develop a program of instruction on personal finance which may be integrated into the curriculum
6 of an appropriate existing course or courses for students in secondary schools.

7 (c) Beginning with the class of students entering 9th grade in the 2024-2025 school year
8 and thereafter, each high school student shall complete one-half credit course of study in personal
9 finance during their 11th or 12th grade year as a requirement for high school graduation. The
10 State Board of Education shall develop and issue implementation guidance to local school boards
11 and other education agencies as to curriculum, content matter standards, eligible teacher
12 certification(s), and graduation requirements the course may fulfill before July 1, 2024.

13 (d) Every student shall complete a course in personal finance prior to high school
14 graduation.
