1 AN ACT to amend the Code of West Virginia, 1931, as amended, by adding thereto a new section,  
2 designated §29-1-15, relating to a development or improvement on land subject to review  
3 by the State Historic Preservation Office or by any other agency, office, or component of  
4 the Division of Culture and History; establishing the division shall not add any additional  
5 impediment to such review beyond those required by applicable Federal laws, rules, or  
6 regulations; and granting rule-making authority.

*Be it enacted by the Legislature of West Virginia:*

**ARTICLE 1. DIVISION OF CULTURE AND HISTORY.**

**§29-1-15. Development or improvement on land; State Historic Preservation Office; rules  
and regulations.**

1 All development or improvement on land, including any disturbance in a right-of-way,  
2 construction project, or infrastructure project, subject to review by the State Historic Preservation  
3 Office or by any other agency, office, or component of the Division of Culture and History for  
4 prehistorical, historical, archaeological, architectural, or cultural value shall be conducted in the  
5 most expedient manner possible. The division shall not add any additional impediment to such  
6 review beyond those required by applicable Federal laws, rules, and regulations and shall have  
7 no authority to comment, regulate, or otherwise cause another governmental entity to comment  
8 upon or regulate, that activity, except in consideration for primacy or continued federal funding.

9 The commissioner shall have the power to make and promulgate rules and regulations in  
10 in conformity with this section, and the commissioner shall modify, upon the effective date of this  
11 legislation, any active rule in conflict with the provisions of this section.


