1 AN ACT making a supplementary appropriation of federal funds out of the Treasury from the
2 balance of federal moneys remaining unappropriated for the fiscal year ending June 30,
3 2023, to the Department of Education, State Board of Education – School Lunch Program,
4 fund 8713, fiscal year 2023, organization 0402, by supplementing and amending the
5 appropriations for the fiscal year ending June 30, 2023.

6 Whereas, The Governor has established the availability of federal funds for expenditure
7 in the fiscal year ending June 30, 2023, which are hereby appropriated by the terms of this
8 supplementary appropriation bill; therefore

Be it enacted by the Legislature of West Virginia:

1 That the total appropriation for the fiscal year ending June 30, 2023, to fund 8713, fiscal
2 year 2023, organization 0402, be supplemented and amended by adding a new item of
3 appropriation as follows:
