1 AN ACT making a supplementary appropriation of public moneys out of the Treasury from the
2 balance of moneys remaining unappropriated for the fiscal year ending June 30, 2023, to
3 the Department of Health and Human Resources, Division of Health – West Virginia Birth-
4 to-Three Fund, fund 5214, fiscal year 2023, organization 0506, by supplementing and
5 amending the appropriations for the fiscal year ending June 30, 2023.

6 Whereas, The Governor has established that there now remains an unappropriated
7 balance in the Department of Health and Human Resources, Division of Health – West Virginia
8 Birth-to-Three Fund, fund 5214, fiscal year 2023, organization 0506, that is available for
9 expenditure during the fiscal year ending June 30, 2023, which is hereby appropriated by the
10 terms of this supplementary appropriation bill; therefore

Be it enacted by the Legislature of West Virginia:

1 That the total appropriation for the fiscal year ending June 30, 2023, to fund 5214, fiscal
2 year 2023, organization 0506, be supplemented and amended by increasing an existing item of
3 appropriation as follows:
