1 AN ACT making a supplementary appropriation of public moneys out of the Treasury from the
2 balance of federal moneys remaining unappropriated for the fiscal year ending June 30,
3 2023, to the Department of Health and Human Resources, Division of Health – West
4 Virginia Safe Drinking Water Treatment, fund 8824, fiscal year 2023, organization 0506,
5 by supplementing and amending the appropriations for the fiscal year ending June 30,
6 2023.

7 Whereas, The Governor has established the availability of federal funds for expenditure
8 in the fiscal year ending June 30, 2023, which are hereby appropriated by the terms of this
9 supplementary appropriation bill; therefore
