1 AN ACT making a supplementary appropriation of public moneys out of the Treasury from the  
2 balance of moneys remaining unappropriated for the fiscal year ending June 30, 2023, to  
3 the Department of Commerce, Division of Natural Resources – License Fund – Wildlife  
4 Resources, fund 3200, fiscal year 2023, organization 0310, by supplementing and  
5 amending the appropriations for the fiscal year ending June 30, 2023.

6 Whereas, The Governor has established that there now remains an unappropriated  
7 balance in the Department of Commerce, Division of Natural Resources – License Fund – Wildlife  
8 Resources, fund 3200, fiscal year 2023, organization 0310, that is available for expenditure during  
9 the fiscal year ending June 30, 2023, which is hereby appropriated by the terms of this  
10 supplementary appropriation bill; therefore

*Be it enacted by the Legislature of West Virginia:*

1 That the total appropriation for the fiscal year ending June 30, 2023, to fund 3200, fiscal  
2 year 2023, organization 0310, be supplemented and amended by increasing an existing item of  
3 appropriation as follows:
