1 AN ACT supplementing and amending the appropriations of public moneys out of the Treasury
2 from the balance of moneys remaining as an unappropriated balance in the State Fund,
3 State Excess Lottery Revenue Fund, Department of Education, fund 3517, fiscal year
4 2023, organization 0402, and to the Department of Education, School Building Authority,
5 fund 3514, fiscal year 2023, organization 0404 by supplementing and amending
6 appropriations for the fiscal year ending June 30, 2023.

7 Whereas, The Governor submitted the Executive Budget Document to the Legislature on
8 January 11, 2023, containing a statement of the State Excess Lottery Revenue Fund, setting forth
9 therein the cash balance as of July 1, 2022, and further included the estimate of revenue for the
10 fiscal year 2023, less net appropriation balances forwarded and regular and surplus
11 appropriations for the fiscal year 2023; and

12 Whereas, It appears from the Governor’s Statement of the State Excess Lottery Revenue
13 Fund, there now remains an unappropriated balance in the State Treasury which is available for
14 expiration during the fiscal year ending June 30, 2023; therefore

Be it enacted by the Legislature of West Virginia:

1 That the total appropriation for the fiscal year ending June 30, 2023, to fund 3517, fiscal
2 year 2023, organization 0402, be supplemented and amended by adding a new item of
3 appropriation as follows:
