1 AN ACT making a supplementary appropriation of federal funds out of the Treasury from the
2 balance of federal moneys remaining unappropriated for the fiscal year ending June 30,
3 2023, to the Division of Human Services – Energy Assistance, fund 8755, fiscal year 2023,
4 organization 0511, by supplementing and amending the appropriations for the fiscal year
5 ending June 30, 2023.

6 Whereas, The Governor has established the availability of federal funds for expenditure
7 in the fiscal year ending June 30, 2023, which is hereby appropriated by the terms of this
