1 AN ACT to amend and reenact §18B-1-6 of the Code of West Virginia, 1931, as amended; to  
2 amend and reenact §18B-1B-4 of said code; to amend and reenact §18B-2A-4 of said  
3 code; to amend and reenact §18B-2B-6 of said code; and to amend said code by adding  
4 thereto a new section, designated §18B-4-5b, all relating generally to carrying concealed  
5 pistol or revolver; regulating the carrying of a concealed pistol or revolver by a person who  
6 holds a current license to carry a concealed deadly weapon on the property of a public  
7 institution of higher education; authorizing the carrying of concealed pistols or revolvers  
8 under certain circumstances and in certain areas on the grounds of an institution of higher  
9 education; eliminating authority of the Higher Education Policy Commission, the Council  
10 for Community and Technical College Education, and the institutional boards of governors  
11 to restrict or regulate the carrying of concealed pistols or revolvers in certain  
12 circumstances in or on areas of an institution of higher education; requiring institutions to  
13 provide storage space for concealed pistols and revolvers; designating these  
14 amendments as the Campus Self-defense Act; expressing legislative intent; and creating  
15 an internal effective date of July 1, 2024.

## **CHAPTER 18B. HIGHER EDUCATION**

### **ARTICLE 1. GOVERNANCE.**

#### **§18B-1-6. Rulemaking.**

1 (a) The commission may promulgate, adopt, amend, or repeal rules, in accordance with  
2 §29A-3A-1 *et seq.* of this code, subject to §18B-1-3 of this code. This grant of rule-making  
3 authority does not limit, overrule, restrict, supplant, or supersede the rule-making authority  
4 provided to the exempted schools.

5 (b) The council may promulgate, adopt, amend, or repeal rules in accordance with §29A-  
6 3A-1 *et seq.* of this code, subject to §18B-1-3 of this code. This grant of rule-making power

7 extends only to those areas over which the council has been granted specific authority and  
8 jurisdiction by law.

9 (c) As it relates to the authority granted to governing boards of state institutions of higher  
10 education to promulgate, adopt, amend, or repeal any rule under this code:

11 (1) "Rule" means any regulation, guideline, directive, standard, statement of policy, or  
12 interpretation of general application which has institution-wide effect or which affects the rights,  
13 privileges, or interests of employees, students, or citizens. Any regulation, guideline, directive,  
14 standard, statement of policy, or interpretation of general application that meets this definition is  
15 a rule for the purposes of this section.

16 (2) Regulations, guidelines, or policies established for individual units, divisions,  
17 departments, or schools of the institution, which deal solely with the internal management or  
18 responsibilities of a single unit, division, department, or school or with academic curricular policies  
19 that do not constitute a mission change for the institution, are excluded from this subsection,  
20 except for the requirements relating to posting.

21 (3) The commission shall promulgate a rule to guide the development of rules made by  
22 the governing boards, including a process for comment by the commission as appropriate, except  
23 the exempted schools, who shall each promulgate their own rules. The council shall promulgate  
24 a rule to guide the development and approval of rules made by the governing boards. The  
25 commission and council shall provide technical assistance in rulemaking as requested. The rules  
26 promulgated by the exempted schools, the commission and council shall include, but are not  
27 limited to, the following provisions which shall be included in the rule on rules adopted by each  
28 governing board of a state institution of higher education:

29 (A) A procedure to ensure that public notice is given and that the right of interested parties  
30 to have a fair and adequate opportunity to respond is protected, including providing for a 30 day  
31 public comment period prior to final adoption of a rule;

32 (B) Designation of a single location where all proposed and approved rules, guidelines,  
33 and other policy statements are posted and can be accessed by the public;

34 (C) A procedure to maximize Internet access to all proposed and approved rules,  
35 guidelines, and other policy statements to the extent technically and financially feasible; and

36 (D) Except for the exempted schools, a procedure for the governing board to follow in  
37 submitting its rules for review and comment by the commission and approval by the council, as  
38 appropriate:

39 (i) The governing boards shall submit rules for review and comment to the commission.

40 (ii) The commission shall return to the governing board its comments and suggestions  
41 within 15 business days of receiving the rule.

42 (iii) If a governing board receives comments or suggestions on a rule from the commission,  
43 it shall record them as part of the minute record. The rule is not effective and may not be  
44 implemented until the governing board holds a meeting and places on the meeting agenda the  
45 comments it has received from the commission.

46 (d) Nothing in this section requires that any rule reclassified or transferred by the  
47 commission or the council under this section be promulgated again under the procedures set out  
48 in §29A-3A-1 *et seq.* of this code unless the rule is amended or modified.

49 (e) The commission and council each shall file with the Legislative Oversight Commission  
50 on Education Accountability any rule it proposes to promulgate, adopt, amend, or repeal under  
51 the authority of this article.

52 (f) The governing boards shall promulgate and adopt any rule which they are required to  
53 adopt by this chapter or chapter 18C of this code no later than July 1, 2011, unless a later date is  
54 specified. On and after this date:

55 (1) Any rule of a governing board which meets the definition set out in subsection (c) of  
56 this section and which has not been promulgated and adopted by formal vote of the appropriate  
57 governing board is void and may not be enforced;

58 (2) Any authority granted by this code which inherently requires the governing board to  
59 promulgate and adopt a rule is void until the governing board complies with this section.

60 (g) Within 15 business days of the adoption of a rule, including repeal or amendment of  
61 an existing rule, and before the change is implemented, a governing board shall furnish a copy of  
62 each rule which it has adopted to the commission or the council, respectively, for review.

63 (h) Annually, by October 1, each governing board shall file with the commission or the  
64 council, as appropriate, a list of all rules that were in effect for that institution on July 1 of that  
65 year, including the most recent date on which each rule was considered and adopted, amended,  
66 or repealed by the governing board. For all rules adopted, amended, or repealed after the effective  
67 date of this section, the list shall include a statement by the chair of the governing board certifying  
68 that the governing board has complied with this section when each listed rule was promulgated  
69 and adopted.

70 (i) Any rule of the commission or council in effect at the time of the re-enactment of this  
71 section or approved by the Legislature during its 2017 Regular Session shall remain in effect and  
72 applicable to an institution of higher education under the jurisdiction of the commission or council  
73 until an institution exercises its authority to adopt a rule pursuant to this chapter.

74 (j) On or after July 1, 2024, a rule adopted pursuant to the provisions of this section may  
75 not restrict or regulate the carrying of a concealed pistol or revolver by a person who holds a  
76 current and valid license to carry a concealed deadly weapon except as expressly authorized in  
77 §18B-4-5b of this code.

## **ARTICLE 1B. HIGHER EDUCATION POLICY COMMISSION.**

### **§18B-1B-4. Powers and duties of Higher Education Policy Commission.**

1 (a) The primary responsibility of the commission is to provide shared services in a cost-  
2 effective manner upon request to the state colleges and universities, the West Virginia Council  
3 for Community and Technical College Education, and the community and technical colleges;  
4 undertake certain statewide and regional initiatives as specifically designated in this chapter,

5 including those related to the administration of grants and scholarships and including those in  
6 conjunction with the council; to review, confirm, or approve certain actions undertaken by  
7 governing boards, as delineated in this chapter; and assist in the development of policy that will  
8 achieve the goals, objectives and priorities found in §18B-1-1a and §18B-1D-1 of this code. The  
9 commission shall exercise its authority and carry out its responsibilities in a manner that is  
10 consistent and not in conflict with the powers and duties assigned by law to the West Virginia  
11 Council for Community and Technical College Education and the powers and duties assigned to  
12 the governing boards. To that end, the commission has the following powers and duties relating  
13 to the governing boards under its jurisdiction:

14 (1) Develop and advance the public policy agenda pursuant to §18B-1D-1 *et seq.* of this  
15 code to address major challenges facing the state, including, but not limited to, the goals,  
16 objectives, and priorities established in this chapter;

17 (2) In conjunction with the council, propose emergency and legislative rules in accordance  
18 with §29A-3A-1 and §18B-1-6 of this code to establish a performance-based funding formula  
19 model the commission and council shall use, beginning in the fiscal year 2024 budget cycle, in  
20 developing their annual budget requests to ensure the fair and equitable distribution and use of  
21 public funds among the state's institutions of higher education, including the statutorily and  
22 administratively exempted schools. This funding formula model shall advance the goals of the  
23 state's post-secondary education system by emphasizing outcomes focused on student success  
24 and institutional mission achievement. The formula shall include a range of variables that shall  
25 be weighted in a manner that corresponds to each institution's mission and provides incentives  
26 for productivity improvements consistent with the goal of strengthening the state's economy and  
27 workforce by developing the most competitive and capable graduates in the nation. The rule  
28 shall, at a minimum:

29 (A) Establish a set of objective performance metrics that reflect and support the state's  
30 higher education goals and priorities and the methodology by which those metrics shall be used  
31 in the allocation of state funds;

32 (B) Ensure that a portion of each institution's base appropriation is allocated based on  
33 outcomes achieved over a defined period of time;

34 (C) Incentivize post-secondary program offerings that align with the state's higher  
35 education and workforce development priorities; and

36 (D) Establish safeguards to ensure stability of the funding formula model including, but  
37 not limited to, providing for periodic reviews of and revision to the performance metrics and  
38 funding methodology in addition to accounting for inflation;

39 (3) In collaboration with the council and the governing boards:

40 (A) Build public consensus around and sustain attention to a long-range public policy  
41 agenda. In developing the agenda, the commission and council shall seek input from the  
42 Legislature, the Governor, the governing boards, and the State Board of Education and local  
43 school districts to create the necessary linkages to assure smooth, effective, and seamless  
44 movement of students through the public education and post-secondary education systems and  
45 to ensure that the needs of public school courses and programs can be fulfilled by the graduates  
46 produced and the programs offered;

47 (B) Assist governing boards in carrying out their duty effectively to govern the individual  
48 institutions of higher education;

49 (4) Serve as a point of contact to state policymakers:

50 (A) The Governor for the public policy agenda; and

51 (B) The Legislature by maintaining a close working relationship with the legislative  
52 leadership and the Legislative Oversight Commission on Education Accountability;

53 (5) Upon request, provide shared services to a state institution of higher education;

54 (6) Administer scholarship and grant programs as provided for in this code;

55 (7) Establish and implement the benchmarks and performance indicators for state colleges  
56 and universities necessary to measure institutional progress in achieving state policy priorities  
57 and institutional missions pursuant to §18B-1D-7 of this code;

58 (8) Establish a formal process for recommending capital investment needs and for  
59 determining priorities for state colleges and universities for these investments for consideration  
60 by the Governor and the Legislature as part of the appropriation request process pursuant to  
61 §18B-19-1 *et seq.* of this code;

62 (9) Except the statutorily and administratively exempted schools, develop standards, and  
63 evaluate governing board requests for capital project financing in accordance with §18B-19-1 *et*  
64 *seq.* of this code;

65 (10) Except the statutorily and administratively exempted schools, ensure that governing  
66 boards manage capital projects and facilities needs effectively, including review and approval of  
67 capital projects, in accordance with §18B-19-1 *et seq.* of this code;

68 (11) Acquire legal services as considered necessary, including representation of the  
69 commission, the governing boards, employees, and officers before any court or administrative  
70 body, notwithstanding any other provision of this code to the contrary. The counsel may be  
71 employed either on a salaried basis or on a reasonable fee basis. In addition, the commission  
72 may, but is not required to, call upon the Attorney General for legal assistance and representation  
73 as provided by law;

74 (12) Employ a chancellor, and any interim chancellor employed shall meet all criteria  
75 required of the chancellor, pursuant to §18B-1B-5 of this code;

76 (13) Employ other staff as necessary and appropriate to carry out the duties and  
77 responsibilities of the commission and the council, in accordance with §18B-4-1 *et seq.* of this  
78 code;

79 (14) Provide suitable offices in Kanawha County for the chancellor, vice chancellors, and  
80 other staff;

81           (15) Approve the total compensation package from all sources for presidents of institutions  
82 under its jurisdiction, except the statutorily exempted schools, as proposed by the governing  
83 boards. The governing boards, except the governing boards of the statutorily exempted schools,  
84 must obtain approval from the commission of the total compensation package both when  
85 institutional presidents are employed initially and afterward when any change is made in the  
86 amount of the total compensation package: *Provided*, That the commission shall receive notice,  
87 but need not approve or confirm, an increase in the compensation of an institutional president  
88 that is exactly in the ratio of compensation increases allocated to all institutional employees and  
89 approved by the governing board to expressly include the president;

90           (16) Assist and facilitate the work of the institutions to implement the policy of the state to  
91 assure that parents and students have sufficient information at the earliest possible age on which  
92 to base academic decisions about what is required for students to be successful in college, other  
93 post-secondary education and careers related, as far as possible, to results from current  
94 assessment tools in use in West Virginia;

95           (17) Approve and implement a uniform standard jointly with the council to determine which  
96 students shall be placed in remedial or developmental courses. The standard shall be aligned  
97 with college admission tests and assessment tools used in West Virginia and shall be applied  
98 uniformly by the governing boards. The chancellors shall develop a clear, concise explanation of  
99 the standard which they shall communicate to the State Board of Education and the state  
100 superintendent of schools;

101           (18) Jointly with the council and in conjunction with the West Virginia Network, support  
102 systemwide technology needs through leveraged consortium purchasing, software, database and  
103 networking support, and other services including, but not limited to, the following:

104           (A) Expanding distance learning and technology networks to enhance teaching and  
105 learning, and promoting access to quality educational offerings with minimum duplication of effort;  
106 and

107 (B) Increasing the delivery of instruction to nontraditional students, providing services to  
108 business and industry, and increasing the management capabilities of the higher education  
109 system.

110 (C) Notwithstanding any other provision of law or this code to the contrary, the council,  
111 commission, and governing boards are not subject to the jurisdiction of the Chief Technology  
112 Officer for any purpose;

113 (19) Propose rules in accordance with §29A-3A-1 *et seq.* and §18B-1-6 of this code to  
114 ensure that, within sound academic policy, a student may transfer and apply toward the  
115 requirements of any post-secondary credential the maximum number of credits earned at any  
116 regionally accredited in-state or out-of-state institution of higher education in a manner that  
117 minimizes the need to repeat courses or incur additional costs. This requirement applies to  
118 transfer processes for all levels of post-secondary programs delivered at community and technical  
119 colleges, baccalaureate-degree-granting institutions, and graduate-degree-granting institutions;

120 (20) Propose rules in accordance with §29A-3A-1 *et seq.* and §18B-1-6 of this code to  
121 develop a program through which a student who has gained knowledge and skills through  
122 employment, participation in education, and training at vocational schools or other education  
123 institutions, or Internet-based education programs, may demonstrate by competency-based  
124 assessment that he or she has the necessary knowledge and skills to be granted academic credit  
125 or advanced placement standing toward the requirements of an associate's degree or a bachelor's  
126 degree at a state institution of higher education;

127 (21) Seek out and attend regional, national, and international meetings and forums on  
128 education and workforce development-related topics as, in the commission's discretion, are  
129 critical for the performance of their duties as members, for the purpose of keeping abreast of  
130 education trends and policies to aid it in developing the policies for this state to meet the  
131 established education goals, objectives, and priorities pursuant to §18B-1-1a and §18B-1D-1 *et*  
132 *seq.* of this code;

133 (22) Promulgate and implement a rule for governing boards and institutions to follow when  
134 considering capital projects pursuant to §18B-19-1 *et seq.* of this code, which rule shall provide  
135 for appropriate deference to the value judgments of governing boards and may not apply to the  
136 statutorily or administratively exempted schools;

137 (23) Submit to the appropriate agencies of the executive and legislative branches of state  
138 government an appropriation request that reflects recommended appropriations for the  
139 commission and the governing boards under its jurisdiction, including the statutorily and  
140 administratively exempted schools. The commission shall submit as part of its appropriation  
141 request the separate recommended appropriation request it received from the council, both for  
142 the council and for the governing boards under the council's jurisdiction. The commission annually  
143 shall submit the proposed allocations based on the funding formula model required by subdivision  
144 (a)(2) of this section;

145 (24) Promulgate rules allocating reimbursement of appropriations, if made available by the  
146 Legislature, to governing boards for qualifying noncapital expenditures incurred in providing  
147 services to students with physical, learning, or severe sensory disabilities;

148 (25) Pursuant to §29A-3A-1 *et seq.* and §18B-1-6 of this code, promulgate rules necessary  
149 or expedient to fulfill the purposes of this chapter and chapter 18C of this code;

150 (26) Determine when a joint rule among the governing boards under its jurisdiction is  
151 necessary or required by law and, in those instances, in consultation with the governing boards  
152 under its jurisdiction, promulgate the joint rule;

153 (27) Promulgate and implement a rule jointly with the council whereby course credit  
154 earned at a community and technical college transfers for program credit at any other state  
155 institution of higher education and is not limited to fulfilling a general education requirement;

156 (28) Promulgate a rule pursuant to §18B-10-1 of this code establishing tuition and fee  
157 policy for all governing boards under the jurisdiction of the commission, except the statutorily and  
158 administratively exempted schools. The rule shall include, but is not limited to, the following:

- 159 (A) Differences among institutional missions;
- 160 (B) Strategies for promoting student access;
- 161 (C) Consideration of charges to out-of-state students; and
- 162 (D) Any other policies the commission and council consider appropriate;
- 163 (29) Notwithstanding any other provision of this code to the contrary sell, lease, convey,
- 164 or otherwise dispose of all or part of any real property that it owns, in accordance with §18B-19-
- 165 1 *et seq.* of this code;
- 166 (30) Provide policy analysis and research focused on issues affecting institutions of higher
- 167 education generally or a geographical region thereof;
- 168 (31) Develop and approve of institutional mission definitions except for the statutorily and
- 169 administratively exempted schools: *Provided*, That the commission may use funds appropriated
- 170 by the Legislature for incentive funds to influence institutional behavior in ways that are consistent
- 171 with public priorities, including the statutorily and administratively exempted schools;
- 172 (32) Review and approve academic programs for governing boards under its jurisdiction,
- 173 except the statutorily and administratively exempted schools. The review and approval includes
- 174 use of institutional missions as a template to judge the appropriateness of both new and existing
- 175 programs and the authority to implement needed changes.
- 176 (A) The commission's authority to review and approve academic programs for the
- 177 statutorily and administratively exempted schools is limited to programs that are proposed to be
- 178 offered at a new location not presently served by that institution: *Provided*, That West Virginia
- 179 University and the West Virginia University Institute of Technology are subject to the commission's
- 180 authority as provided in §18B-1C-2 of this code.
- 181 (B) In reviewing and approving academic programs, the commission shall focus on the
- 182 following policy concerns:
- 183 (i) New programs may not be implemented which change the institutional mission, unless
- 184 the institution also receives approval for expanding the institutional mission;

185 (ii) New programs which require significant additional expense investments for  
186 implementation may not be implemented unless the institution demonstrates that:

187 (I) The expenses shall be addressed by effective reallocations of existing institutional  
188 resources; or

189 (II) The expenses can be legitimately spread out over future years and shall be covered  
190 by reasonably anticipated additional net revenues from new enrollments;

191 (iii) A new undergraduate program which is significantly similar to an existing program  
192 already in the geographic service area may not be implemented unless the institution requesting  
193 the new program demonstrates a compelling need in the service area that is not being met by the  
194 existing program: *Provided*, That the academic programs of the statutorily and administratively  
195 exempted schools are not to be taken into consideration except as it relates to academic programs  
196 offered at West Virginia University in Beckley and West Virginia University Institute of Technology  
197 in Beckley.

198 (C) The commission shall approve or disapprove proposed academic degree programs in  
199 those instances where approval is required as soon as practicable. The commission shall  
200 maintain by rule a format model by which a new program approval shall be requested by an  
201 institution. When a request for approval of a new program is submitted to the commission, the  
202 chancellor shall provide notice within two weeks as to whether the submission meets the required  
203 format, and if it does not the chancellor shall identify each specific deficiency and return the  
204 request to the institution. The institution may refile the request for approval with the commission  
205 to address any identified deficiencies. Within 30 days after the chancellor's confirmation that the  
206 request meets the required format, the commission shall either approve or disapprove the request  
207 for the new program. The commission may not withhold approval unreasonably.

208 (33) Distribute of funds appropriated to the commission, including incentive and  
209 performance-based funds;

210 (34) Administer state and federal student aid programs under the supervision of the vice  
211 chancellor for administration, including promulgation of rules necessary to administer those  
212 programs;

213 (35) Serve as the agent to receive and disburse public funds when a governmental entity  
214 requires designation of a statewide higher education agency for this purpose;

215 (36) Develop and distribute information, assessment, accountability, and personnel  
216 systems for state colleges and universities, including maintaining statewide data systems that  
217 facilitate long-term planning and accurate measurement of strategic outcomes and performance  
218 indicators;

219 (37) Jointly with the council, promulgate and implement rules for licensing and oversight  
220 for both public and private degree-granting and nondegree-granting institutions that provide post-  
221 secondary education courses or programs in the state. The council has authority and  
222 responsibility for approval of all post-secondary courses or programs providing community and  
223 technical college education as defined in §18B-1-2 of this code;

224 (38) Develop, facilitate and oversee statewide and regional projects and initiatives related  
225 to providing post-secondary education at the baccalaureate level and above as those using funds  
226 from federal categorical programs or those using incentive and performance-based funds from  
227 any source;

228 (39) (A) For all governing boards under its jurisdiction, except for the statutorily exempted  
229 schools, review institutional operating budgets, review, and approve capital budgets, and  
230 distribute incentive and performance-based funds.

231 (B) For the governing boards of the statutorily exempted schools, the commission shall  
232 distribute incentive and performance-based funds and may review and comment upon the  
233 institutional operating budgets and capital budgets. The commission's comments, if any, shall be  
234 made part of the governing board's minute record and shall be filed with the Legislative Oversight  
235 Commission on Education Accountability;

236 (40) Provide information, research, and recommendations to state colleges and  
237 universities relating to programs and vocations with employment rates greater than 90 percent  
238 within six months post-graduation; and

239 (41) Provide information, research, and recommendations to state colleges and  
240 universities on coordinating with the West Virginia State Board of Education about complimentary  
241 programs.

242 (b) In addition to the powers and duties provided in this section and any other powers and  
243 duties assigned to it by law, the commission has other powers and duties necessary or expedient  
244 to accomplish the purposes of this chapter and chapter 18C of this code: *Provided*, That the  
245 provisions of this subsection do not shift management authority from the governing boards to the  
246 commission.

247 (c) The commission may withdraw specific powers of a governing board under its  
248 jurisdiction for a period not to exceed two years, if the commission determines that either of the  
249 following conditions exist:

250 (1) The commission has received information, substantiated by independent audit, of  
251 significant mismanagement or failure to carry out the powers and duties of the governing board  
252 according to state law; or

253 (2) Other circumstances which, in the view of the commission, severely limit the capacity  
254 of the governing board to exercise its powers or carry out its duties and responsibilities.

255 The commission may not withdraw specific powers for a period exceeding two years.  
256 During the withdrawal period, the commission shall take all steps necessary to reestablish sound,  
257 stable, and responsible institutional governance.

258 (d) On or after July 1, 2024, nothing in this section authorizes the commission to restrict  
259 or regulate the carrying of a concealed pistol or revolver by a person who holds a current and  
260 valid license to carry a concealed deadly weapon except as expressly authorized in §18B-4-5b of  
261 this code.

**ARTICLE 2A. INSTITUTIONAL BOARDS OF GOVERNORS.**

**§18B-2A-4. Powers and duties of governing boards generally.**

1           Each governing board separately shall:

2           (a) Determine, control, supervise, and manage the financial, business, and education  
3 policies and affairs of the state institution of higher education under its jurisdiction;

4           (b) Develop a master plan for the institution under its jurisdiction.

5           (1) The ultimate responsibility for developing and updating each master plan at the  
6 institution resides with the governing board, but the ultimate responsibility for approving the final  
7 version of each master plan, including periodic updates, resides with the commission or council,  
8 as appropriate: *Provided*, That commission approval is not required for master plans of exempted  
9 schools.

10          (2) Each master plan shall include, but is not limited to, the following:

11          (A) A detailed demonstration of how the master plan will be used to meet the goals,  
12 objectives, and priorities of the compact;

13          (B) A well-developed set of goals, objectives, and priorities outlining missions, degree  
14 offerings, resource requirements, physical plant needs, personnel needs, enrollment levels, and  
15 other planning determinates and projections necessary in a plan to assure that the needs of the  
16 institution's area of responsibility for a quality system of higher education are addressed;

17          (C) Documentation showing how the governing board involved the commission or council,  
18 as appropriate, constituency groups, clientele of the institution, and the general public in the  
19 development of all segments of the master plan.

20          (3) The plan shall be established for periods of not fewer than three nor more than five  
21 years and shall be revised periodically as necessary, including adding or deleting programs. The  
22 commission may review and comment upon the master plan of an exempted school. The  
23 commission may review, but may not approve or disapprove, additions or deletions of degree  
24 programs, except as expressly provided for in §18B-1B-4(a)(39) of this code.

25 (4) For the exempted schools, the master plan shall be updated at least bi-annually and  
26 include the steps taken to meet the legislatively established policies contained in §18B-1D-1 *et*  
27 *seq.* of this code and reports on each of the data elements identified in §18B-1D-1 *et seq.* of this  
28 code, including progress that the exempted schools are making relating to retention and  
29 graduation rates for resident students by organization and each college within the organization.  
30 The exempted schools shall provide copies of their respective master plan to the Legislative  
31 Oversight Commission on Education Accountability and the commission.

32 (c) Develop a 10-year campus development plan in accordance with §18B-19-1 *et seq.* of  
33 this code;

34 (d) Prescribe for the institution, under its jurisdiction, in accordance with its master plan  
35 and compact, specific functions and responsibilities to achieve the goals, objectives, and priorities  
36 established in §18B-1-1 *et seq.* and §18B-1D-1 *et seq.* of this code to meet the higher education  
37 needs of its area of responsibility and to avoid unnecessary duplication;

38 (e) Direct the preparation of an appropriation request for the institution under its  
39 jurisdiction, which relates directly to missions, goals and projections found in the master plan and  
40 the compact;

41 (f) Consider, revise, and submit for review and approval to the commission or council, as  
42 appropriate, an appropriation request on behalf of the institution under its jurisdiction, including  
43 the exempted schools;

44 (g) Review, at least every five years, all academic programs offered at the institution under  
45 its jurisdiction. The review shall address the viability, adequacy, and necessity of the programs in  
46 relation to established state goals, objectives and priorities, the master plan, the compact, and  
47 the education and workforce needs of its responsibility district. As a part of the review, each  
48 governing board shall require the institution under its jurisdiction to conduct periodic studies of its  
49 graduates and their employers to determine placement patterns and the effectiveness of the

50 education experience. Where appropriate, these studies should coincide with the studies required  
51 of many academic disciplines by their accrediting bodies;

52 (h) Ensure that the sequence and availability of academic programs and courses offered  
53 by the institution under its jurisdiction is such that students have the maximum opportunity to  
54 complete programs in the time frame normally associated with program completion. Each  
55 governing board is responsible to see that the needs of nontraditional college-age students are  
56 appropriately addressed and, to the extent it is possible for the individual governing board to  
57 control, to assure core course work completed at the institution is transferable to any other state  
58 institution of higher education for credit with the grade earned;

59 (i) Subject to §18B-1B-1 *et seq.* of this code, approve the teacher education programs  
60 offered in the institution under its control. In order to permit graduates of teacher education  
61 programs to receive a degree from a nationally accredited program and in order to prevent  
62 expensive duplication of program accreditation, the commission may select and use one  
63 nationally recognized teacher education program accreditation standard as the appropriate  
64 standard for program evaluation;

65 (j) Involve faculty, students, and classified employees in institution-level planning and  
66 decision making when those groups are affected;

67 (k) Subject to federal law and pursuant to §18B-7-1 *et seq.*, §18B-8-1 *et seq.*, §18B-9-1 *et*  
68 *seq.*, and §18B-9A1 *et seq.* of this code and to rules adopted by the commission and the council,  
69 administer a system for the management of personnel matters, including, but not limited to,  
70 discipline for employees at the institution under its jurisdiction: *Provided*, That any rules adopted  
71 by the commission and the council do not apply to exempted schools;

72 (l) Administer a system for hearing employee grievances and appeals. Notwithstanding  
73 any other provision of this code to the contrary, the procedure established in §6C-2-1 *et seq.* of  
74 this code is the exclusive mechanism for hearing prospective employee grievances and appeals;

75 (m) Solicit and use or expend voluntary support, including financial contributions and  
76 support services, for the institution under its jurisdiction;

77 (n) Appoint a president for the institution under its jurisdiction, subject to §18B-1B-6 of this  
78 code;

79 (o) Conduct written performance evaluations of the president, pursuant to §18B-1B-6 of  
80 this code;

81 (p) Employ all faculty and staff at the institution under its jurisdiction. The employees  
82 operate under the supervision of the president, but are employees of the governing board;

83 (q) Submit to the commission or council, as appropriate, any data or reports requested by  
84 the commission or council within the time frame set by the commission or council;

85 (r) Enter into contracts or consortium agreements with the public schools, private schools,  
86 or private industry to provide technical, vocational, college preparatory, remedial, and customized  
87 training courses at locations either on campuses of the state institutions of higher education or at  
88 off-campus locations in the institution's responsibility district. To accomplish this goal, the boards  
89 may share resources among the various groups in the community;

90 (s) Provide and transfer funds and property to certain corporations pursuant to §18B-12-  
91 10 of this code;

92 (t) Delegate, with prescribed standards and limitations, the part of its power and control  
93 over the business affairs of the institution to the president in any case where it considers the  
94 delegation necessary and prudent in order to enable the institution to function in a proper and  
95 expeditious manner and to meet the requirements of its master plan and compact. If a governing  
96 board elects to delegate any of its power and control under this subsection, it shall enter the  
97 delegation in the minutes of the meeting when the decision was made and shall notify the  
98 commission or council, as appropriate. Any delegation of power and control may be rescinded by  
99 the appropriate governing board, the commission or council, as appropriate, at any time, in whole

100 or in part, except that the commission may not revoke delegations of authority made by the  
101 governing board of the exempted schools.

102 (u) Unless changed by the commission or the council, as appropriate, continue to abide  
103 by existing rules setting forth standards for accepting advanced placement credit for the institution  
104 under its jurisdiction. Individual departments at a state institution of higher education, with  
105 approval of the faculty senate, may require higher scores on the advanced placement test than  
106 scores designated by the governing board when the credit is to be used toward meeting a  
107 requirement of the core curriculum for a major in that department;

108 (v) Consult, cooperate, and coordinate with the State Treasurer and the State Auditor to  
109 update as necessary and maintain an efficient and cost-effective system for the financial  
110 management and expenditure of appropriated and non-appropriated revenue at the institution  
111 under its jurisdiction. The system shall ensure that properly submitted requests for payment are  
112 paid on or before the due date but, in any event, within 15 days of receipt in the State Auditor's  
113 Office;

114 (w) In consultation with the appropriate chancellor and the Secretary of the Department of  
115 Administration, develop, update as necessary, and maintain a plan to administer a consistent  
116 method of conducting personnel transactions, including, but not limited to, hiring, dismissal,  
117 promotions, changes in salary or compensation, and transfers at the institution under its  
118 jurisdiction. Each personnel transaction shall be accompanied by the appropriate standardized  
119 system or forms, as appropriate, which shall be submitted to the respective governing board and  
120 the Department of Administration:

121 (1) Not later than July 1, 2012, the Department of Administration shall make available to  
122 each governing board the option of using a standardized electronic system for these personnel  
123 transactions.

124 (2) The Secretary of the Department of Administration may suspend a governing board's  
125 participation in the standardized electronic system if he or she certifies to the Governor that the

126 governing board has failed repeatedly and substantially to comply with the department's policies  
127 for administering the electronic system;

128 (x) Notwithstanding any other provision of this code to the contrary, transfer funds from  
129 any account specifically appropriated for its use to any corresponding line item in a general  
130 revenue account at any agency or institution under its jurisdiction as long as the transferred funds  
131 are used for the purposes appropriated;

132 (y) Transfer funds from appropriated special revenue accounts for capital improvements  
133 under its jurisdiction to special revenue accounts at agencies or institutions under its jurisdiction  
134 as long as the transferred funds are used for the purposes appropriated in accordance with §18B-  
135 19-1 *et seq.* of this code;

136 (z) Notwithstanding any other provision of this code to the contrary, acquire necessary  
137 legal services, including representation of the governing board, its institution, employees, and  
138 officers before any court or administrative body. The counsel may be employed either on a  
139 salaried basis or on a reasonable fee basis. In addition, the governing board may, but is not  
140 required to, call upon the Attorney General for legal assistance and representation as provided  
141 by law;

142 (aa) Contract and pay for disability insurance for a class or classes of employees at a state  
143 institution of higher education under its jurisdiction; and

144 (bb) Contract and pay for any supplemental employee benefit, at the governing board's  
145 discretion: *Provided*, That if such supplemental benefit program incurs institutional expense, then  
146 the board may not delegate the approval of the supplemental employee benefit program.

147 (cc) On or after July 1, 2024, nothing in this section authorizes a governing board to restrict  
148 or regulate the carrying of a concealed pistol or revolver by a person who holds a current and  
149 valid license to carry a concealed deadly weapon except as expressly authorized in §18B-4-5b of  
150 this code.

**ARTICLE 2B. WEST VIRGINIA COUNCIL FOR COMMUNITY AND TECHNICAL COLLEGE EDUCATION.**

**§18B-2B-6. Powers and duties of the council.**

1           (a) The council is the sole agency responsible for administration of vocational-technical-  
2 occupational education and community and technical college education in the state. The council  
3 has jurisdiction and authority over the community and technical colleges and the statewide  
4 network of independently accredited community and technical colleges as a whole, including  
5 community and technical college education programs as defined in §18B-1-2 of this code.

6           (b) The council shall propose rules pursuant to §18B-1-6 and §29A-3A-1 *et seq.* of this  
7 code to implement the provisions of this section and applicable provisions of §18B-1D-1 *et seq.*  
8 of this code;

9           (1) To implement the provisions of §18B-1D-1 *et seq.* of this code relevant to community  
10 and technical colleges, the council may propose rules jointly with the commission, or separately,  
11 and may choose to address all components of the accountability system in a single rule or may  
12 propose additional rules to cover specific components;

13           (2) The rules pertaining to financing policy and benchmarks and indicators required by this  
14 section shall be filed with the Legislative Oversight Commission on Education Accountability by  
15 October 1, 2008. Nothing in this subsection requires other rules of the council to be promulgated  
16 again under the procedure set forth in §29A-3A-1 *et seq.* of this code unless such rules are  
17 rescinded, revised, altered, or amended; and

18           (3) The Legislature finds that an emergency exists and, therefore, the council shall  
19 propose an emergency rule or rules to implement the provisions of this section relating to the  
20 financing policy and benchmarks and indicators in accordance with §18B-1-6 and §29A-3A-1 *et*  
21 *seq.* of this code by October 1, 2008. The emergency rule or rules may not be implemented  
22 without prior approval of the Legislative Oversight Commission on Education Accountability.

23 (c) The council may relating to the authority established in subsection (a) of this section:

24 (1) Develop, oversee, and advance the public policy agenda for community and technical  
25 college education for the purpose of accomplishing the mandates of this section, including, but  
26 not limited to, the following:

27 (A) Achieving the goals and objectives established in §18B-1-1 *et seq.* and §18B-1D-1 *et*  
28 *seq.* of this code;

29 (B) Addressing the goals and objectives contained in the institutional compacts created  
30 pursuant to §18B-1D-7 of this code; and

31 (C) Developing and implementing the master plan described in §18B-1D-5 of this code;

32 (2) Propose a legislative rule pursuant to subsection (b) of this section and §29A-3A-1 *et*  
33 *seq.* of this code to develop and implement a financing policy for community and technical college  
34 education in West Virginia. The rule shall:

35 (A) Provide an adequate level of education and general funding for institutions pursuant  
36 to §18B-1A-5 of this code;

37 (B) Serve to maintain institutional assets, including, but not limited to, human and physical  
38 resources and deferred maintenance;

39 (C) Establish a plan for strategic funding to strengthen capacity for support of community  
40 and technical college education; and

41 (D) Establish a plan that measures progress and provides performance-based funding to  
42 institutions which make significant progress in the following specific areas:

43 (i) Achieving the objectives and priorities established in §18B-1D-1 *et seq.* of this code;

44 (ii) Serving targeted populations, especially working age adults 25 years of age and over;

45 (iii) Providing access to high-cost, high-demand, technical programs in every region of the  
46 state;

47 (iv) Increasing the percentage of functionally literate adults in every region of the state;

48 and

49 (v) Providing high-quality community and technical college education services to residents  
50 of every region of the state.

51 (3) Create a policy leadership structure relating to community and technical college  
52 education capable of the following actions:

53 (A) Developing, building public consensus around, and sustaining attention to a long-  
54 range public policy agenda. In developing the agenda, the council shall seek input from the  
55 Legislature and the Governor and specifically from the State Board of Education and local school  
56 districts in order to create the necessary linkages to assure smooth, effective, and seamless  
57 movement of students through the public education and post-secondary education systems and  
58 to ensure that the needs of public school courses and programs can be fulfilled by the graduates  
59 produced and the programs offered;

60 (B) Ensuring that the governing boards of the institutions under the council's jurisdiction  
61 carry out their duty effectively to govern the individual institutions of higher education; and

62 (C) Holding each community and technical college and the statewide network of  
63 independently accredited community and technical colleges as a whole accountable for  
64 accomplishing their missions and achieving the goals and objectives established in §18B-1-1 *et*  
65 *seq.*, §18B-1D-1 *et seq.*, and §18B-3C-1 *et seq.* of this code;

66 (4) Develop for inclusion in the statewide public agenda, a plan for raising education  
67 attainment, increasing adult literacy, promoting workforce and economic development, and  
68 ensuring access to advanced education for the citizens of West Virginia;

69 (5) Provide statewide leadership, coordination, support, and technical assistance to the  
70 community and technical colleges and to provide a focal point for visible and effective advocacy  
71 for their work and for the public policy agendas approved by the commission and council;

72 (6) Review and adopt annually all institutional compacts for the community and technical  
73 colleges pursuant to the provisions of §18B-1D-7 of this code;

74 (7) Fulfill the mandates of the accountability system established in §18B-1D-1 *et seq.* of  
75 this code and report on progress in meeting established goals, objectives, and priorities to the  
76 elected leadership of the state;

77 (8) Propose a legislative rule pursuant to subsection (b) of this section and §29A-3A-1 *et*  
78 *seq.* of this code to establish benchmarks and indicators in accordance with the provisions of this  
79 subsection;

80 (9) Establish and implement the benchmarks and performance indicators necessary to  
81 measure institutional progress:

82 (A) In meeting state goals, objectives, and priorities established in §18B-1-1 *et seq.* and  
83 §18B-1D-1 *et seq.* of this code;

84 (B) In carrying out institutional missions; and

85 (C) In meeting the essential conditions established in §18B-3C-1 *et seq.* of this code;

86 (10) Establish a formal process for identifying needs for capital investments and for  
87 determining priorities for these investments for consideration by the Governor and the Legislature  
88 as part of the appropriation request process. Notwithstanding the language in §18B-1B-4(a)(11)  
89 of this code, the commission is not a part of the process for identifying needs for capital  
90 investments for the statewide network of independently accredited community and technical  
91 colleges;

92 (11) Draw upon the expertise available within the Governor's Workforce Investment Office  
93 and the West Virginia Development Office as a resource in the area of workforce development  
94 and training;

95 (12) Acquire necessary legal services including representation of the council, its  
96 institutions, employees, and officers before any court or administrative body, notwithstanding any  
97 other provision of this code to the contrary. The counsel may be employed either on a salaried  
98 basis or on a reasonable fee basis. In addition, the council may, but is not required to, call upon  
99 the Attorney General for legal assistance and representation as provided by law;

100 (13) Employ a chancellor for community and technical college education pursuant to §18B-  
101 2B-3 of this code;

102 (14) Employ other staff as necessary and appropriate to carry out the duties and  
103 responsibilities of the council consistent with the provisions of §18B-4-2 of this code;

104 (15) Employ other staff as necessary and appropriate to carry out the duties and  
105 responsibilities of the council who are employed solely by the council;

106 (16) Provide suitable offices in Charleston for the chancellor and other staff: *Provided,*  
107 That the offices may be located outside of Charleston at a technology and research center:  
108 *Provided, however,* That the current employees of WVNET shall not be moved from Monongalia  
109 County without legislative approval;

110 (17) Approve the total compensation package from all sources for presidents of community  
111 and technical colleges, as proposed by the governing boards. The governing boards must obtain  
112 approval from the council of the total compensation package both when presidents are employed  
113 initially and subsequently when any change is made in the amount of the total compensation  
114 package;

115 (18) Establish and implement policies and procedures to ensure that students may transfer  
116 and apply toward the requirements for a degree the maximum number of credits earned at any  
117 regionally accredited in-state or out-of-state higher education institution with as few requirements  
118 to repeat courses or to incur additional costs as is consistent with sound academic policy;

119 (19) Establish and implement policies and programs, jointly with the community and  
120 technical colleges, through which students who have gained knowledge and skills through  
121 employment, participation in education and training at vocational schools or other education  
122 institutions, or Internet-based education programs, may demonstrate by competency-based  
123 assessment that they have the necessary knowledge and skills to be granted academic credit or  
124 advanced placement standing toward the requirements of an associate degree or a bachelor's  
125 degree at a state institution of higher education;

126           (20) Seek out and attend regional and national meetings and forums on education and  
127 workforce development-related topics, as council members consider critical for the performance  
128 of their duties. The council shall keep abreast of national and regional community and technical  
129 college education trends and policies to aid members in developing the policies for this state that  
130 meet the education goals and objectives established in §18B-1-1 *et seq.* and §18B-1D-1 *et seq.*  
131 of this code;

132           (21) Assess community and technical colleges for the payment of expenses of the council  
133 or for the funding of statewide services, obligations, or initiatives related specifically to the  
134 provision of community and technical college education;

135           (22) Promulgate rules allocating reimbursement of appropriations, if made available by the  
136 Legislature, to community and technical colleges for qualifying noncapital expenditures incurred  
137 in the provision of services to students with physical, learning, or severe sensory disabilities;

138           (23) Assume the prior authority of the commission in examining and approving tuition and  
139 fee increase proposals submitted by community and technical college governing boards as  
140 provided in §18B-10-1 of this code;

141           (24) Develop and submit to the commission, a single budget for community and technical  
142 college education that reflects recommended appropriations for community and technical colleges  
143 and that meets the following conditions:

144           (A) Incorporates the provisions of the financing rule mandated by this section to measure  
145 and provide performance funding to institutions which achieve or make significant progress  
146 toward achieving established state objectives and priorities;

147           (B) Considers the progress of each institution toward meeting the essential conditions set  
148 forth in §18B-3C-3 of this code, including independent accreditation; and

149           (C) Considers the progress of each institution toward meeting the goals, objectives, and  
150 priorities established in §18B-1D-1 *et seq.* of this code and its approved institutional compact.

151 (25) Administer and distribute the independently accredited community and technical  
152 college development account;

153 (26) Establish a plan of strategic funding to strengthen capacity for support and assure  
154 delivery of high-quality community and technical college education in all regions of the state;

155 (27) Foster coordination among all state-level, regional and local entities providing post-  
156 secondary vocational education or workforce development, and coordinate all public institutions  
157 and entities that have a community and technical college mission;

158 (28) Assume the principal responsibility for oversight of those community and technical  
159 colleges seeking independent accreditation and for holding governing boards accountable for  
160 meeting the essential conditions pursuant to §18B-3C-1 *et seq.* of this code;

161 (29) Advise and consent in the appointment of the presidents of the community and  
162 technical colleges pursuant to §18B-1B-6 of this code. The role of the council in approving a  
163 president is to assure through personal interview that the person selected understands and is  
164 committed to achieving the goals and objectives established in the institutional compact and in  
165 §18B-1-1 *et seq.*, §18B-1D-1 *et seq.*, and §18B-3C-1 *et seq.* of this code;

166 (30) Provide a single, statewide link for current and prospective employers whose needs  
167 extend beyond one locality;

168 (31) Provide a mechanism capable of serving two or more institutions to facilitate joint  
169 problem-solving in areas including, but not limited to the following:

170 (A) Defining faculty roles and personnel policies;

171 (B) Delivering high-cost technical education programs across the state;

172 (C) Providing one-stop service for workforce training to be delivered by multiple  
173 institutions; and

174 (D) Providing opportunities for resource-sharing and collaborative ventures;

175           (32) Provide support and technical assistance to develop, coordinate, and deliver effective  
176 and efficient community and technical college education programs and services in all regions of  
177 the state;

178           (33) Assist the community and technical colleges in establishing and promoting links with  
179 business, industry, and labor in the geographic areas for which each community and technical  
180 college is responsible;

181           (34) Develop alliances among the community and technical colleges for resource sharing,  
182 joint development of courses and courseware, and sharing of expertise and staff development;

183           (35) Serve aggressively as an advocate for development of a seamless curriculum;

184           (36) Cooperate with all providers of education services in the state to remove barriers  
185 relating to a seamless system of public and higher education and to transfer and articulate  
186 between and among community and technical colleges, state colleges and universities, and public  
187 education, preschool through grade 12;

188           (37) Encourage the most efficient use of available resources;

189           (38) Coordinate with the commission in informing public school students, their parents,  
190 and teachers of the academic preparation that students need in order to be prepared adequately  
191 to succeed in their selected fields of study and career plans, including presentation of academic  
192 career fairs;

193           (39) Jointly with the commission, approve and implement a uniform standard, as  
194 developed by the chancellors, to determine which students shall be placed in remedial or  
195 developmental courses. The standard shall be aligned with college admission tests and  
196 assessment tools used in West Virginia and shall be applied uniformly by the governing boards  
197 throughout the public higher education system. The chancellors shall develop a clear, concise  
198 explanation of the standard which the governing boards shall communicate to the State Board of  
199 Education and the State Superintendent of Schools;

200 (40) Develop and implement strategies and curriculum for providing developmental  
201 education which shall be applied by any state institution of higher education providing  
202 developmental education;

203 (41) Develop a statewide system of community and technical college programs and  
204 services in every region of West Virginia for competency-based certification of knowledge and  
205 skills, including a statewide competency-based associate degree program;

206 (42) Review and approve all institutional master plans for the community and technical  
207 colleges pursuant to §18B-2A-4 of this code;

208 (43) Propose rules for promulgation pursuant to subsection (b) of this section and §29A-  
209 3A-1 *et seq.* of this code that are necessary or expedient for the effective and efficient  
210 performance of community and technical colleges in the state;

211 (44) In its sole discretion, transfer any rule under its jurisdiction, other than a legislative  
212 rule, to the jurisdiction of the governing boards who may rescind, revise, alter, or amend any rule  
213 transferred pursuant to rules adopted by the council and provide technical assistance to the  
214 institutions under its jurisdiction to aid them in promulgating rules;

215 (45) Develop for inclusion in the higher education report card, as defined in §18B-1D-8 of  
216 this code, a separate section on community and technical colleges. This section shall include, but  
217 is not limited to, evaluation of the institutions based upon the benchmarks and indicators  
218 developed in subdivision (9) of this subsection;

219 (46) Facilitate continuation of the Advantage Valley Community College Network under  
220 the leadership and direction of Marshall Community and Technical College;

221 (47) Initiate and facilitate creation of other regional networks of affiliated community and  
222 technical colleges that the council finds to be appropriate and in the best interests of the citizens  
223 to be served;

224 (48) Develop with the State Board of Education plans for secondary and post-secondary  
225 vocational-technical-occupational and adult basic education, including, but not limited to, the  
226 following:

227 (A) Policies to strengthen vocational-technical-occupational and adult basic education;  
228 and

229 (B) Programs and methods to assist in the improvement, modernization, and expanded  
230 delivery of vocational-technical-occupational and adult basic education programs;

231 (49) Distribute federal vocational education funding provided under the Carl D. Perkins  
232 Vocational and Technical Education Act of 1998, PL 105-332, with an emphasis on distributing  
233 financial assistance among secondary and post-secondary vocational-technical-occupational and  
234 adult basic education programs to help meet the public policy agenda.

235 In distributing funds the council shall use the following guidelines:

236 (A) The State Board of Education shall continue to be the fiscal agent for federal vocational  
237 education funding;

238 (B) The percentage split between the State Board of Education and the council shall be  
239 determined by rule promulgated by the council under the provisions of §29A-3A-1 *et seq.* of this  
240 code. The council shall first obtain the approval of the State Board of Education before proposing  
241 a rule;

242 (50) Collaborate, cooperate, and interact with all secondary and post-secondary  
243 vocational-technical-occupational and adult basic education programs in the state, including the  
244 programs assisted under the federal Carl D. Perkins Vocational and Technical Education Act of  
245 1998, PL 105-332, and the Workforce Investment Act of 1998, to promote the development of  
246 seamless curriculum and the elimination of duplicative programs;

247 (51) Coordinate the delivery of vocational-technical-occupational and adult basic  
248 education in a manner designed to make the most effective use of available public funds to  
249 increase accessibility for students;

250 (52) Analyze and report to the State Board of Education on the distribution of spending for  
251 vocational-technical-occupational and adult basic education in the state and on the availability of  
252 vocational-technical-occupational and adult basic education activities and services within the  
253 state;

254 (53) Promote the delivery of vocational-technical-occupational education, adult basic  
255 education, and community and technical college education programs in the state which  
256 emphasize the involvement of business, industry, and labor organizations;

257 (54) Promote public participation in the provision of vocational-technical-occupational  
258 education, adult basic education, and community and technical education at the local level,  
259 emphasizing programs which involve the participation of local employers and labor organizations;

260 (55) Promote equal access to quality vocational-technical-occupational education, adult  
261 basic education, and community and technical college education programs to handicapped and  
262 disadvantaged individuals, adults in need of training and retraining, single parents, homemakers,  
263 participants in programs designed to eliminate sexual bias and stereotyping, and criminal  
264 offenders serving in correctional institutions;

265 (56) Meet annually between the months of October and December with the Advisory  
266 Committee of Community and Technical College Presidents created pursuant to §18B-2B-8 of  
267 this code to discuss those matters relating to community and technical college education in which  
268 advisory committee members or the council may have an interest;

269 (57) Accept and expend any gift, grant, contribution, bequest, endowment, or other money  
270 for the purposes of this article;

271 (58) Assume the powers set out in §18B-2B-9 of this code. The rules previously  
272 promulgated by the State College System Board of Directors pursuant to that section and  
273 transferred to the commission are hereby transferred to the council and shall continue in effect  
274 until rescinded, revised, altered or amended by the council;

275 (59) Pursuant to the provisions of subsection (b) of this section and §29A-3A-1 *et seq.* of  
276 this code, promulgate a uniform joint legislative rule with the commission for the purpose of  
277 standardizing, as much as possible, the administration of personnel matters among the  
278 institutions of higher education;

279 (60) Determine when a joint rule among the governing boards of the community and  
280 technical colleges is necessary or required by law and, in those instances and in consultation with  
281 the governing boards, promulgate the joint rule;

282 (61) Promulgate a joint rule with the commission establishing tuition and fee policy for all  
283 institutions of higher education. The rule shall include, but is not limited to, the following:

284 (A) Comparisons with peer institutions;

285 (B) Differences among institutional missions;

286 (C) Strategies for promoting student access;

287 (D) Consideration of charges to out-of-state students; and

288 (E) Any other policies the commission and council consider appropriate;

289 (62) In cooperation with the West Virginia Division of Highways, study a method for  
290 increasing the signage signifying community and technical college locations along the state  
291 interstate highways, and report to the Legislative Oversight Commission on Education  
292 Accountability regarding any recommendations and required costs; and

293 (63) Implement a policy jointly with the commission whereby any course credit earned at  
294 a community and technical college transfers for program credit at any other state institution of  
295 higher education and is not limited to fulfilling a general education requirement.

296 (d) In addition to the powers and duties listed in subsections (a), (b), and (c) of this section,  
297 the council has the following general powers and duties related to its role in developing,  
298 articulating, and overseeing the implementation of the public policy agenda for community and  
299 technical colleges:

300 (1) Planning and policy leadership including a distinct and visible role in setting the state's  
301 policy agenda for the delivery of community and technical college education and in serving as an  
302 agent of change;

303 (2) Policy analysis and research focused on issues affecting the community and technical  
304 college network as a whole or a geographical region thereof;

305 (3) Development and implementation of each community and technical college mission  
306 definition including use of incentive and performance funds to influence institutional behavior in  
307 ways that are consistent with achieving established state goals, objectives, and priorities;

308 (4) Academic program review and approval for the institutions under its jurisdiction,  
309 including the use of institutional missions as a template to judge the appropriateness of both new  
310 and existing programs and the authority to implement needed changes;

311 (5) Development of budget and allocation of resources for institutions delivering  
312 community and technical college education, including reviewing and approving institutional  
313 operating and capital budgets, and distributing incentive and performance-based funding;

314 (6) Acting as the agent to receive and disburse public funds related to community and  
315 technical college education when a governmental entity requires designation of a statewide higher  
316 education agency for this purpose;

317 (7) Development, establishment, and implementation of information, assessment, and  
318 internal accountability systems, including maintenance of statewide data systems that facilitate  
319 long-term planning and accurate measurement of strategic outcomes and performance indicators  
320 for community and technical colleges;

321 (8) Jointly with the commission, development, establishment, and implementation of  
322 policies for licensing and oversight of both public and private degree-granting and nondegree-  
323 granting institutions that provide post-secondary education courses or programs;

324 (9) Development, implementation, and oversight of statewide and regionwide projects and  
325 initiatives related specifically to providing community and technical college education such as

326 those using funds from federal categorical programs or those using incentive and performance-  
327 based funding from any source; and

328 (10) Quality assurance that intersects with all other duties of the council particularly in the  
329 areas of planning, policy analysis, program review and approval, budgeting and information, and  
330 accountability systems.

331 (e) The council may withdraw specific powers of a governing board under its jurisdiction  
332 for a period not to exceed two years if the council makes a determination that any of the following  
333 conditions exist:

334 (1) The governing board has failed for two consecutive years to develop an institutional  
335 compact as required in §18B-1D-7 of this code;

336 (2) The council has received information, substantiated by independent audit, of significant  
337 mismanagement or failure to carry out the powers and duties of the Board of Governors according  
338 to state law; or

339 (3) Other circumstances which, in the view of the council, severely limit the capacity of the  
340 Board of Governors to carry out its duties and responsibilities.

341 The period of withdrawal of specific powers may not exceed two years during which time  
342 the council is authorized to take steps necessary to reestablish the conditions for restoration of  
343 sound, stable and responsible institutional governance.

344 (f) In addition to the powers and duties provided for in subsections (a), (b), (c), and (d) of  
345 this section, and any others assigned to it by law, the council has those powers and duties  
346 necessary or expedient to accomplish the purposes of this article; and

347 (g) When the council and commission, each, is required to consent, cooperate,  
348 collaborate, or provide input into the actions of the other the following conditions apply:

349 (1) The body acting first shall convey its decision in the matter to the other body with a  
350 request for concurrence in the action;

351 (2) The commission or the council, as the receiving body, shall place the proposal on its  
352 agenda and shall take final action within 60 days of the date when the request for concurrence is  
353 received; and

354 (3) If the receiving body fails to take final action within 60 days, the original proposal stands  
355 and is binding on both the commission and the council.

356 (h) On or after July 1, 2024, nothing in this section provides the authority to restrict or  
357 regulate the carrying of a concealed pistol or revolver by a person who holds a current and valid  
358 license to carry a concealed deadly weapon except as expressly authorized in §18B-4-5b of this  
359 code.

#### **ARTICLE 4. GENERAL ADMINISTRATION.**

##### **§18B-4-5b. Concealed carry on higher education campuses; exceptions.**

1 (a) Subject to the provisions of subsection (b) of this section, a person holding a current  
2 and valid license to carry a concealed deadly weapon may carry a concealed pistol or revolver on  
3 the campus and in the buildings of a state institution of higher education. This subsection only  
4 applies to areas of the campus and buildings of a state institution of higher education under the  
5 custodial possession of the state institution of higher education and does not include areas rented,  
6 leased, or under an exclusive agreement for the full-time occupancy and use of a private entity.

7 (b) The provisions of subsection (a) of this section do not limit the authority of a state  
8 institution of higher education to regulate possession of a concealed pistol or revolver by a person  
9 holding a current and valid license to carry a concealed deadly weapon in the following locations  
10 when in compliance with §61-7-14 of this code:

11 (1) At an organized event taking place at a stadium or arena with a capacity of more than  
12 1,000 spectators;

13 (2) At a daycare facility located on the property of the state institution of higher education;

14 (3) In the secure area of any building used by a law-enforcement agency on the property  
15 of the state institution for higher education;

16 (4) In an area of the property of the state institution of higher education that has adequate  
17 security measures in place to ensure that pistols or revolvers are not carried by the public into the  
18 area. As used in this section, "adequate security measures" means the use of electronic  
19 equipment and armed personnel at public entrances to detect and restrict the carrying of any  
20 pistols or revolvers into the area, including, but not limited to, metal detectors, metal detector  
21 wands, or any other equipment used for similar purposes to ensure that pistols or revolvers are  
22 not carried in those areas by members of the public;

23 (5) In an on-campus room or rooms in which a student or employee disciplinary proceeding  
24 is being held;

25 (6) In sole occupancy offices on the campus and in the buildings of the state institution of  
26 higher education. "Sole occupancy office" means a room with at least one door and walls that  
27 extend to the ceiling that is assigned to a single person as his or her workspace. This subdivision  
28 does not authorize a state institution of higher education to prohibit, regulate, or restrict faculty or  
29 staff members who hold a current and valid license to carry a concealed deadly weapon from  
30 carrying a concealed pistol or revolver in his or her assigned office;

31 (7) At a primary or secondary education school-sponsored function being held in a specific  
32 location on the property of the state institution of higher education that is rented, leased, or under  
33 the exclusive use of the West Virginia Department of Education, the West Virginia Secondary  
34 Schools Activities Commission, a county school board, or local public school for the actual period  
35 of time the function is occurring;

36 (8) At a private function that is being held in a specific location on the property of the state  
37 institution of higher education that is rented, leased, or under the exclusive use of an entity that  
38 is not affiliated with the state institution of higher education for the actual period of time the function  
39 is occurring;

40 (9) In any area on the property of the state institution of higher education where possession  
41 of a firearm is prohibited by state or federal law;

42 (10) In specifically designated areas in which patient-care or mental health counseling is  
43 being provided;

44 (11) In high hazardous and animal laboratories, defined as laboratories with:

45 (A) Greater than 55 gallons of Class I flammable liquids and/or significant quantities of  
46 acids, bases, organics, pyrophorics, peroxides, bio-hazardous materials, extremely toxic  
47 materials, or pyrophoric or toxic gases classified NFPA 704 Category 3 or higher;

48 (B) Hazardous gases with K-size or larger cylinders containing corrosive, reactive,  
49 flammable, toxic, and/or oxidizer gases classified NFPA 704 Category 2 or higher;

50 (C) MRI and/or NMR equipment capable of generating significant magnetic fields with field  
51 strength of at least 5 gauss is measured outside the equipment or 5 gauss line typically at least 3  
52 feet and as much as 20 feet from equipment;

53 (D) Large cylinders of acetylene; or

54 (E) Animal research laboratory spaces in locations not accessible to the public or generally  
55 accessible to students and staff, or

56 (12) In on-campus residence halls, except common areas such as lounges, dining areas,  
57 and study areas.

58 (c) An employee whose employment responsibilities require him or her to be in an on-  
59 campus residence hall and who holds a current and valid license to carry a concealed deadly  
60 weapon is permitted to carry a concealed revolver or pistol on or about his or her person while  
61 present in on-campus residence halls for purposes of his or her employment.

62 (d) Institutions of higher education shall provide either: (1) A secure location for the storage  
63 of a pistol or revolver in at least one of the institution's on-campus residence halls; or (2) make  
64 available an appropriate safe that may be installed in a resident's room in any of the institution's  
65 on-campus residence halls. If an institution chooses to make a storage room available to on-  
66 campus residents at an on-campus residence hall, the institution shall develop a policy that  
67 reserves an appropriate amount of rooms in the on-campus residence hall where the storage

68 room is located for on-campus residents with a current and valid license to carry a concealed  
69 deadly weapon. The institution shall make the storage room available at all times during which  
70 the on-campus residence hall is open and fully operational for use by its residents. If West Virginia  
71 University chooses to provide secure locations instead of making safes available to students, it  
72 shall provide a secure location in at least two on-campus residence halls at its Morgantown  
73 campus and one at each of its Beckley and Keyser campuses.

74 (e) An institution of higher education may charge a reasonable fee for the use of the secure  
75 storage location or a safe.

76 (f) The provisions of subsection (a) of this section do not limit the authority of a state  
77 institution of higher education from taking disciplinary action against a student or employee with  
78 a valid license to carry a concealed deadly weapon who is convicted of a violation of §61-7-14 of  
79 this code related to carrying a firearm in a location listed in subsection (b) of this section.

80 (g) Notwithstanding any provision of subsection (a) of this section to the contrary, while on  
81 the campus or in the buildings of a state institution of higher education, a holder of a license to  
82 carry a concealed deadly weapon or any other person not expressly authorized to do so by the  
83 state institution of higher education, may not carry a pistol or revolver which is partially or wholly  
84 visible, or intentionally or knowingly display a firearm in plain view of another person in a way or  
85 manner to cause, or threaten, a breach of the peace, regardless of whether the firearm is  
86 holstered. A holder of a license to carry a concealed deadly weapon who violates this subsection  
87 may, in addition to any applicable criminal charges, be subject to discipline the state institution of  
88 higher education considers appropriate.

89 (h) It is the intent of the Legislature to establish, by this act, conditions under which persons  
90 with a current and valid license to carry a concealed deadly weapon may carry a concealed pistol  
91 or revolver at a state institution of higher education. When a person exercises the rights granted  
92 by this section, neither the carrying of a concealed pistol or revolver, nor any other conduct of  
93 person involving a concealed pistol or revolver, shall be construed to be an act of the state  
94 institution of higher education nor of the state, and no liability for any such actions of such person

95 shall be imputed to the state institution of higher education, its officers, agents, or employees,  
96 unless the state institution of higher education has expressly requested or directed such person  
97 to carry a concealed pistol or revolver: *Provided*, That the failure to provide adequate security  
98 measures at any building or location at a state institution of higher education where the carrying  
99 of a concealed pistol or revolver is not permitted shall not give rise to a cause action or any liability  
100 whatsoever related to or arising from the carrying of a concealed pistol or revolver by any person.

101 (i) For the purposes of this section, a "license to carry a concealed deadly weapon" refers  
102 to a current and valid license, lawfully issued by the State of West Virginia pursuant to §61-7-4 or  
103 §61-7-4a of this code, or a current and valid license or permit recognized under §61-7-6a of this  
104 code.

105 (j) These amendments to this section enacted during the regular session of the  
106 Legislature, 2023, may be cited as the Campus Self-defense Act.

107 (k) The provisions of this section apply on or after July 1, 2024.
