1 AN ACT making a supplementary appropriation of public moneys out of the Treasury from the
2 balance of federal moneys remaining unappropriated for the fiscal year ending June 30,
3 2024, to the Department of Homeland Security, Division of Emergency Management, fund
4 8727, fiscal year 2024, organization 0606, by supplementing and amending the
5 appropriations for the fiscal year ending June 30, 2024.

1 WHEREAS, The Governor has established the availability of federal funds for expenditure
2 in the fiscal year ending June 30, 2024, which are hereby appropriated by the terms of this
3 supplementary appropriation bill; therefore

Be it enacted by the Legislature of West Virginia:

1 That the total appropriation for the fiscal year ending June 30, 2024, to fund 8727, fiscal
2 year 2024, organization 0606, be supplemented and amended by increasing an existing item of
3 appropriation as follows:




