1 AN ACT making a supplementary appropriation of public moneys out of the Treasury from the  
2 balance of federal moneys remaining unappropriated for the fiscal year ending June 30,  
3 2024, to the Department of Health and Human Resources, Division of Health –  
4 Consolidated Medical Service Fund, fund 8723, fiscal year 2024, organization 0506, by  
5 supplementing and amending the appropriations for the fiscal year ending June 30, 2024.

1 WHEREAS, The Governor has established the availability of federal funds for expenditure  
2 in the fiscal year ending June 30, 2024, which are hereby appropriated by the terms of this  
3 supplementary appropriation bill; therefore

*Be it enacted by the Legislature of West Virginia:*

1 That the total appropriation for the fiscal year ending June 30, 2024, to fund 8723, fiscal  
2 year 2024, organization 0506, be supplemented and amended by increasing an existing item of  
3 appropriation as follows:




