1 AN ACT making a supplementary appropriation of public moneys out of the Treasury from the  
2 balance of moneys remaining unappropriated for the fiscal year ending June 30, 2024, to  
3 the Executive, Department of Agriculture – West Virginia Spay Neuter Assistance Fund,  
4 fund 1481, fiscal year 2024, organization 1400, by supplementing and amending the  
5 appropriations for the fiscal year ending June 30, 2024.

1 WHEREAS, The Governor has established that there now remains an unappropriated  
2 balance in the Executive, Department of Agriculture – West Virginia Spay Neuter Assistance  
3 Fund, fund 1481, fiscal year 2024, organization 1400, that is available for expenditure during the  
4 fiscal year ending June 30, 2024, which is hereby appropriated by the terms of this supplementary  
5 appropriation bill; therefore

*Be it enacted by the Legislature of West Virginia:*

1 That the total appropriation for the fiscal year ending June 30, 2024, to fund 1481, fiscal  
2 year 2024, organization 1400, be supplemented and amended by adding a new item of  
3 appropriation as follows:
