1 AN ACT making a supplementary appropriation of public moneys out of the Treasury from the  
2 balance of federal moneys remaining unappropriated for the fiscal year ending June 30,  
3 2024, to the Department of Arts, Culture, and History, National Coal Heritage Area  
4 Authority, fund 8869, fiscal year 2024, organization 0432, by supplementing and amending  
5 the appropriations for the fiscal year ending June 30, 2024.

1 WHEREAS, The Governor has established the availability of federal funds for expenditure  
2 in the fiscal year ending June 30, 2024, which are hereby appropriated by the terms of this  
3 supplementary appropriation bill; therefore

*Be it enacted by the Legislature of West Virginia:*

1 That the total appropriation for the fiscal year ending June 30, 2024, to fund 8869, fiscal




