1	AN ACT supplementing and amending the appropriations of public moneys out of the Treasury
2	from the balance of moneys remaining as an unappropriated surplus balance in the State
3	Fund, State Excess Lottery Revenue Fund, by adding a new item of appropriation to the
4	Department of Human Services, fund 5365, fiscal year 2025, organization 0511 for the
5	fiscal year ending June 30, 2025.
1	WHEREAS, The Governor submitted the Executive Budget Document to the Legislature
2	on February 12, 2025, containing a statement of the State Excess Lottery Revenue Fund, setting
3	forth therein the cash balance as of July 1, 2024, and further included the estimate of revenue for
4	the fiscal year 2025, less net appropriation balances forwarded and regular and surplus
5	appropriations for the fiscal year 2025; and
6	WHEREAS, It appears from the Governor's Statement of the State Excess Lottery
7	Revenue Fund, there now remains an unappropriated surplus balance in the State Treasury which
8	is available for appropriation during the fiscal year ending June 30, 2025; therefore
	Be it enacted by the Legislature of West Virginia:
1	That the total appropriation for the fiscal year ending June 30, 2025, to fund 5365, fiscal
2	year 2025, organization 0511, be supplemented and amended by adding a new item of
3	appropriation as follows:
